## **Home Office/Occupation/Business**

## **Information Sheet**



The below table outlines requirements for Home Based Occupations/Businesses and will assist applicants in determining their classification depending on what requirements they meet, and in turn, which classification their operation will be.

Home Office	A Home Office means a home occupation limited to a business carried out solely within a dwelling by a resident of the dwelling but which does not –  • entail clients or customers traveling to and from the dwelling;  • involve the advertising signs on the premises; or  • require any external change to the appearance of the dwelling.	No
Home Occupation	<ul> <li>A Home Occupation means an occupation carried out in a dwelling or on land around a dwelling by an occupier of the dwelling which -</li> <li>does not employ any person not a member of the occupier's household;</li> <li>will not cause injury to or adversely affect the amenity of the neighbourhood;</li> <li>does not occupy an area greater than 20 square metres;</li> <li>does not display a sign exceeding 0.2 square metres;</li> <li>does not involve the retail sale, display or hire of goods of any nature;</li> <li>in relation to vehicles and parking, does not result in the requirement for a greater number of parking facilities than normally required for a single dwelling or an increase in traffic volume in the neighbourhood, does not involve the presence, use or calling of a vehicle more than 2 tonnes tare weight, and does not include provision for the fuelling, repair or maintenance of motor vehicles; and</li> <li>does not involve the use of an essential service of greater capacity than normally required in the zone</li> </ul>	No
Home Business	<ul> <li>A Home Business means a business, service or profession carried out in a dwelling or on land around a dwelling by an occupier of the dwelling which-</li> <li>does not employ more than 2 people not members of the occupier's household;</li> <li>will not cause injury to or adversely affect the amenity of the neighbourhood;</li> <li>does not occupy an area greater than 50 square metres;</li> <li>does not involve the retail sale, display or hire of goods of any nature;</li> <li>in relation to vehicles and parking, does not result in traffic difficulties as a result of the inadequacy of parking or an increase in traffic volumes in the neighbourhood, and does not involve the presence, use or calling of a vehicle more than 3.5 tonnes tare weight; and does not involve the use of an essential service of greater capacity than normally required in the zone.</li> </ul>	Yes
Rural Home Business	means a dwelling or land around a dwelling used by an occupier of the dwelling to carry out a business, service or occupation if the carrying out of the business, service or occupation —  • does not involve employing more than 2 people who are not members of the occupier's household; and	Yes

- will not cause injury to or adversely affect the amenity of the neighbourhood; and
- does not occupy an area greater than 200m<sup>2</sup>; and
- does not involve the retail sale, display or hire of any goods unless the sale, display or hire is done only be means of the Internet; and
- does not result in traffic difficulties as a result of the inadequacy of parking or an increase in traffic volumes in the neighbourhood; and
- does not involve the presence, use or calling of more than 3 vehicles at any one time or of a vehicle of more than 30 tonnes gross weight;

## **Planning Approval**

Development Standards for Planning approval for a Home Business/Rural Home Business:

- Is granted to the person to whom it was issued;
- Is not capable of being transferred or assigned to any other person;
- On the sale of the property or change in ownership of the land the home business entitlement ceases; and
- May have conditions attached to the approval.
- Does not constitute any other permits or approvals required such as a Building Permit or Environmental Health Approval.

## **Information Required**

In addition to the standard application form and fee requirements, the following information is required to accompany with any planning application for Home Business/Rural Home Business:

- A short description on the function/type of business and its operations
- Whether the home business is proposed to be carried out by a person who resides at the property.
- Whether the home business is proposed to employ any person who does not reside at the property:
- Whether the home business is likely to cause injury or to adversely affect the amenity of the neighbourhood.
- The area in m<sup>2</sup> that the home business will occupy.
- Whether there is any signage proposed associated with the home business.
- Whether the home business involves retail sale, display or hire of goods of any nature.
- How many vehicle movements the home business will generate per day. Include any employees (for home businesses), deliveries, customers;
- The types of vehicles that are associated with the home business.
- The maximum number of clients per day attending the property associated with the home business; and
- Any other information relevant to the home business
