PURPOSE

The purpose of this report is to recommend to the Council the adoption of the Compliance Audit Return for the calendar year 1 January 2022 to 31 December 2022.

BACKGROUND

A Compliance Audit is required to be completed once in each calendar year.

STATUTORY ENVIRONMENT

The Compliance Audit is required pursuant to Section 7.13 of the Local Government Act 1995. The Local Government (Audit) Regulations 1996 includes the following sub regulations in Regulation 14:

- '(3A) The local government's audit committee is to review the compliance audit return and is to report to the council the results of that review.
- (3) After the audit committee has reported to the council under sub regulation (3A), the compliance audit return is to be
 - (a) presented to the council at a meeting of the council; and
 - (b) adopted by the council; and
 - (c) recorded in the minutes of the meeting at which it is adopted.'

After the Compliance Audit Return has been presented to the Council, a certified copy of the return together with:

- (a) A copy of the relevant section of the minutes referred to in the regulations; and
- (b) any additional information explaining or qualifying the Compliance Audit is to be submitted to the Department of Local Government, Sport and Cultural Industries by 31 March 2023.

EXTERNAL CONSULTATION

No external consultation has occurred in relation to this report.

There are no financial implications for this report.

The completed Compliance Audit Return is attached to the report. The following comments are made in respect to the non-compliance.

Section 5.75 of the Local Government Act 1995 requires any relevant person other than the CEO to lodge with the CEO a primary return in the prescribed form within 3 months of the start day.

On 29 March 2022 a relevant employee commenced with the Shire and the primary return was overlooked. A letter was sent to the relevant employee on 22 December 2022, and the primary return was received on 6 January 2023.
