#### 6 REPORTS OF COMMITTEE MEMBERS AND OFFICERS

#### 6.1 COMMUNITY EMERGENCY SERVICES MANAGER REPORT

**LEMC** - Since the last BFAC meeting there have been two ordinary meetings of the Local Emergency Management Committee and six special COVID 19 meetings.

**LGGS** - DFES have offered \$140,980 for next year's budget, a countered offer of \$280,541 with capital expenditure over and above for a 12,000 litre bulk water tanker for the financial year 2020/2021. The amount for this coming year of \$155,000 has been agreed too. This is an increase of 9.17%.

The 12,000 litre bulk water tanker, if approved will be housed and operated by the Narpyn Bush Fire Brigade and will also be a regional asset in strike teams and task forces. This will be a great unit to assist in any incident here in Plantagenet or major incident with one of our neighbouring shires.

**GRANTS** – Funding is being looked at for water tanks at the Karri Oaks and Woogenellup aircraft landing sites. This will move forward upon approval from the Department of Biodiversity, Conservation and Attractions (DBCA) that they will use the sites for water bomber activities during an incident. If this goes ahead then the

Strategic Water Tanks (STW) will also be available for use by brigade appliances and private units at a fire if the water bombers are not utilised.

**PPC/PPE** – there is extra funding that will be used to purchase some of the remaining requests from brigade members and should be here by the end of June. There is very little stock in my office. Personal protective clothing and equipment should be worn at all incidents.

**TRAINING** – Since September the training courses completed are as follows;

- Plantation Firefighting x 2
- Fire Control Officer
- Burn over training and refresher
- Introduction to fire fighting x 2
- Bush fire fighting
- AIIMS Awareness x 2
- Ground Controller

Training was suspended from March and some courses cancelled but has resumed from June with restrictions.

- Ground Controller x 3
- Mental Health First Aid
- Machine Supervision x 2
- On road driving
- Plantation Fire Fighting x 2
- Sector commander
- Leadership Fundamentals
- Fire control officer
- Off road driving
- Water Bomber refilling

#### **INCIDENTS**

There have been 66 primary and secondary call outs so far this year, including the Stirling Range National Park.

It is really important that ComCen is made aware of any and all incidents that you attend and that the Officer in Charge completes an Incident Report including the members that attended.

Whats App has been very useful for incidents. One non-fire related incident that comes to mind was a child missing on a farm out east. The message went out via a Whats App and had a very good turn out and a good result after an hour or so of searching.

Not submitting an Incident Report could result in you not being insured if a claim is made later down the track as there will be no record of the callout. This will also affect the Local Government Grants Scheme if you want to apply for new resources etc.

#### **VEHICLES**

All Appliances have been serviced with only a couple of problems outstanding.

Forest Hill will be due a new appliance this year and is currently on the wait list to be built.

#### AVL

Don't forget to test these - it is for your safety. This will not take long if you are on station, pull out the vehicle and push the AVL button 4 times in 4 seconds, it will then flash green and red while testing and then go solid green once complete.

#### **RADIOS**

Albany Communications have serviced all of the radios and completed the movements.

If anyone is having issues please report it ASAP, same goes if your radio is damaged or gets broken during the off season please report so that a service call can be lodged to get it fixed.

The directory will be out once all the appointments have been confirmed. Please check the details are correct so that they can be printed.

#### 6.2 CHIEF BUSH FIRE CONTROL OFFICER REPORT

This season to date there have been 66 call outs.

Thank you to all that were able to turn out.

Regional Operational Advisory Committee (ROAC) will be using a collaborative approach to the Request for Resourcing (R2R) applications from local governments within the Great Southern area.

Incident reports have been completed and sent through to the Shire. This is an important task that needs to be completed as soon as possible after the response to the incident and thank you to all who complete these forms.

I encourage everyone to start to use Whats App for incident communications.

The Bush Fire Local Law 2020 will need to go to a Chief and Deputies meeting then to a BFAC meeting for further updates.

A discussion on the Unallocated Crown Land (UCL) and Unmanaged Reserves (UMR) outside of the gazetted town sites, particularly in the Porongurup area, has been had with the Department of Biodiversity Conservations and Attractions (DBCA) for them to undertake the reduction of fire fuels.

There will be a workshop in October this year prior to the fire season.

Norm Handasyde – CBFCO would like to thank all of the deputy chiefs, fire control officers, the fire weather officers, base radio operators, brigade captains and volunteers for their hard work, commitment and dedication to this volunteer organisation.

#### 6.3 FIRE WEATHER OFFICER REPORT

As I near the end of my second year as Chief Fire Weather Officer, I would like to take this opportunity to thank all brigade fire weather officers for their time and effort. All their valuable data and advice makes the decision on implementing harvest and vehicle movement ban possible and accurate. I would like to encourage any of the brigades who currently don't have a fire weather officer, to explore the possibility of nominating someone for the position

The Shire's geographical area is so vast and the weather conditions vary significantly from east to west. Any extra weather information is valuable in implementing and removing the harvest and vehicle movement bans.

I remember one particularly difficult day this season where the weather conditions were very challenging.

A stationary trough caused very strong north-east winds to the east of the Albany Highway which included parts of the Narpyn and Middle Ward brigades. Whilst a harvest and vehicle movement ban was in place for the eastern zone, in hindsight, the parts of the two brigades west of the Albany highway should have been included. While the weather conditions to the west of these brigade areas remained quite mild and there was no cause for concern.

I would also like to make a special mention of my Deputy Chief Fire Weather Officer, Brent Wearmouth, for filling in for me whilst I was unavailable. Being a volunteer positon it is difficult to be present all of the time and having a capable deputy makes a huge difference.

By the end of the main fire season, there had been six harvest and vehicle movement bans imposed. There were three in December and three in March, of which only two started midmorning and the rest starting around 2pm.

The trending weather conditions seemed to be quite mild in the mornings before deteriorating rapidly in the afternoons. This resulted in the need for future bans to be implemented more often, but for shorter periods of time.

With a drier finish to the season and prolonged spell to any decent rainfall, the potential for serious fires to occur was a very real possibility

To spread the load and allow all the base operators some air time, Mr Ron Caudwell suggested we operate on a roster. See below. This will be continued next year.

When a deputy base radio operator is on duty they will use the call sign "6TN Base" as opposed to "6TN Deputy Base". This saves some confusion and time when making or receiving calls.

When calling us when not on duty use the following call signs. Valerie and Roger Randall are "Forest Hill 12", Jacqui Burcham "Kendenup 10" and Ron Caudwell "Porongurup 9".

Anyone calling 6TN Base should allow 20 seconds or so before recalling. This will give us time to get to the radio if not on hand.

Throughout the year (including during the off season) we continue to monitor the radio, take notes and provide assistance where possible when there is a fire. We do this until the last person has left the fire ground and/or the last fire truck is either stood down on site or is back in the shed.

There are currently 71 names (71 names 18/19) on the sked listing, we generally call 67 (63, 18/19) of these on a daily basis.

If you are going away for more than a day or two for any reason, please let 6TN Base know (text or phone). Continually not answering the sked call may inadvertently let unsavoury individuals know that you are away. We will skip you for the period you are away.

There are still some gaps relating to recording the names of individuals attending fires i.e. who is on the fire ground, when they arrived and when they departed. This information should be communicated by Text SMS messages or on the phone directly to 6TN Base. This is better than announcing the names over the radio for obvious security reasons.

Identifying the Incident Controller can sometimes be an issue. We try to keep meticulous notes on fire incidents throughout the year and are sometimes left wondering who is in charge. Hopefully this will further improve this coming year 20/21.

Fire appliances mostly continue to be reporting their departure from their shed and when departing the fire ground and again when arriving back at their sheds. This was great, thanks. We don't like calling Fire Captains late at night to confirm their trucks are back in the shed!

#### Year 2020/21

I would like to nominate myself for the position of Base Radio operator for Year 20/21 Currently I will be working in QLD through to mid-December. Val Randall (if nominated) will deputise in my absence until my return.

I suggest we advertise in the Plantagenet News for expressions of interest for VBFB base radio operators. This is to see what hidden talent is around. Eventually we will need replacements and being able to train them over a period of time is important.

#### 6.5 DEPARTMENT OF FIRE AND EMERGENCY SERVICES (DFES) REPORT

This has been a challenging year with a long fire season followed by the COVID 19 pandemic and then the loss of a fellow colleague and friend District Officer Robert Lake.

Prescription burns happening in Denmark have had protesters turning up disrupting operations. Please be mindful when planning burns here in Plantagenet.

Incident reports are very important for funding and resourcing your brigades in the coming years.

When planning burns make sure you document everything, including decisions made and why. This will ensure you have a good plan for the burn and constantly monitor the conditions during and immediately after the burn.

Thank you to the new CESM Mike Barnes for making my job so much easier.

DFES are keen to upgrade brigade sheds like Woogenellup and Rocky Gully. I would like to see some meetings going forward towards the progression to update these facilities.

#### Question

When will prescriptions be issued for the Porongurup UCL/UMR?

#### Answer

Legislation states the all UCL/UMR areas outside of the gazetted town sites are the responsibility of the Department of Conservation, Biodiversity and Attractions (DBCA).

#### <u>Statement</u>

Woogenellup bush fire brigade was approached with updating the fire shed; this money could be better spent within the region.

#### Response

Woogenellup bush fire shed does need replacing to bring it up to the minimum standard for volunteers. Some more consultation with the Woogenellup Brigade needs to be organised for the next local government grant scheme budget submission.

#### Question

What plans are in place with DFES for any protesters that arrive at prescription burns?

#### Answer

This is a new thing just started with the DBCA burns in Denmark. There were no protesters at a recent burn in Hopetoun. Our legal department is looking into this to provide some guidance for future burns

Council has received support from DBCA from both districts of Franklin and Albany as well as support from DFES Albany. All of this together with the councils support has been sent to Mark Gilbett of DBCA Perth aviation branch on the 22 of April and again on the 12 May. We await his response.

A new trailer for the RRU is in the budget and with a surplus 3 inch pump this will be very effective.

#### Question

This will have to be through grant moneys as Council cannot spend rate payers funds on private land.

A discussion was had over some minor adjustments for ease of reading and clarity these were as follows;

Front Page - Change of date and Change of picture.

Page 2 - Change of background from red to orange and add Community Emergency Services Manager in the last text box

Page 3 - Centre titles, paragraph three change height of minimum clearance 3 metres to 4 metres, paragraph six change height of minimum clearance 3 metres to 4 metres and centre pictures and wording.

Page 4 - Centre titles, paragraph three change height of minimum clearance 3 metres to 4 metres and paragraph four change height of minimum clearance 3 metres to 4 metres.

Page 5 - Centre titles, paragraph two change height of minimum clearance 3 metres to 4 metres and paragraph two the wording ABANDONED BUILDING changed to red.

Discussion for page 12 was not accepted. This was to align the compliance date of the Fire Mitigation Notice with the start of the restricted period; for the eastern zone 3 October and the western zone 2 November.

Instead of the start of the prohibited period; currently eastern zone 15 November and the western zone 15 December

This would ensure that mitigation measures for asset protections zones etc. have been installed prior to any permits being issued and would also increase time frame for the rangers to inspect properties and reinspection of non-compliance properties well before the summer.

The Bushfire Resilience in the Great Southern, (BRIGS) Program is still in progress, the COVID 19 has delayed the community consultation. The community consultation has been rescheduled for Kendenup on Tuesday 4 August and Mount Barker Hill on Thursday 6 August 2020

Reminder to write the permit holders phone number and map references of the area to be burnt on the permit.

#### 7.5 000 PRANK CALLS - CBFCO

Calls are being received by the DFES communications centre for bush fire brigades to attend legitimate hazard reduction burns. These calls are being made with mobiles that have had their sim card removed. Consequentially the callers' information is not being sent as it would if the sim card was still in the phone.

This was raised at the Local Emergency Management Committee (LEMC) meeting recently and Mr N Handasyde will raise this issue at the Regional Operations Advisory Committee (ROAC) meeting in September this year and with the Bush Fire Association.

#### 7.7.1 Diesel Particulate Diffusers (DPD) on fire appliances

Some fire appliances in Albany have had difficulties with the DPD causing the appliance to go into limp mode and sometimes not shut off for a period of time.
