4 REPORTS OF COMMITTEE MEMBERS AND OFFICERS

4.1 REVIEW SHIRE OF PLANTAGENET RAV NETWORK

Discussion was held regarding the categorisation of the final 11 roads, completed by Mr Le Cerf. All Committee members agreed with the recommendations provided.

So far the Committee has used the proposed new system to identify the 'types' of vehicles using particular roads. From here, the Committee will set speed conditions on these road categories and conditions on particular sections of road as required.

A summary of the proposed system is provided below (as agreed at the meeting held on 20 March 2012):

Category 1 Vehicles up to 19.5m 'As of right' vehicles / general

endorsement

Category 2 Vehicles up to 27.5m Vehicle categories 2c, 3a, 4a Category 3 Vehicles up to 36.5m Vehicle categories 6a, 6b, 7b

Note: Vehicle categories 2c, 3a etc are referenced from the RAV Heavy Vehicle Operations - Vehicle Description and Configuration Chart.

Roads may then be classified as controlled (C) or uncontrolled (U).

If a road is controlled, it may have special conditions attached and a permit provided (from the Shire) for either:

- a. Single trip;
- b. 3 months; or
- c. 12 months.

Mr Le Cerf led a discussion regarding the development of conditions for each category. The following conditions were agreed to for each of the proposed categories:

3U

Network 2, 3, 4, 5, 6 & 7 Conditions

- Maximum speed on gravel roads 60km/h
- Maximum speed on sealed roads 80km/h

<u>3C</u>

Network 2 & 3 Conditions

- Maximum speed on gravel roads 60km/h
- Maximum speed on sealed roads 80km/h

Network 4, 5, 6 & 7 Conditions

- A current written approval from the Local Government, permitting use of the road, must be carried and produced on demand
- Maximum speed on gravel roads 60km/h
- Maximum speed on sealed roads 80km/h

2U

Network 2, 3, 4 & 5 Conditions

- Maximum speed through townsites 50km/h
- Maximum speed outside townsites on gravel roads 60km/h
- Maximum speed outside townsites on sealed roads 80km/h
- Special endorsement from Local Government required for Network 6 or Network 7

2C

Network 2, 3, 4 & 5

- A current written approval from the Local Government, permitting use on the road, must be carried and produced on demand
- Maximum speed through townsites 50km/h
- Maximum speed outside townsites on gravel roads 60km/h
- Maximum speed outside townsites on sealed roads 80km/h
- Special endorsement required from Local Government for Network 6 or Network 7

 Speeds being limited to 60km/h on unsealed roads and 80km/h on sealed roads without pavement markings and 90km/h on sealed roads with pavement markings or 10km/h lower than the posted speed limit of roads under 80km/h or whichever is the lesser.

Action: Mr Le Cerf to forward information and recommendations to Main Roads WA for comment.

5 GENERAL BUSINESS / MATTERS ARISING

Mr Le Cerf advised that work is progressing regarding the Council's Asset Management Plan which will tie in with the proposed gravel strategy and new road hierarchy. Mr Le Cerf noted the proposed new road hierarchy and gravel strategy will be forwarded to the Council in the near future.

6 NEXT MEETING

The Committee agreed to schedule a further meeting upon receipt of comments from Main Roads WA regarding recommendations for new categorisation and conditions for roads throughout the Shire.
