PURPOSE

The purpose of this report is to present the draft Heavy Plant Replacement Program (HPRP) as part of the annual budget preparations. This draft plan extrapolates expected expenditure out to 2032 / 2033.

BACKGROUND

The Shire of Plantagenet Heavy Plant Replacement Program (HPRP) details the retention and changeover schedule for the Shire's fleet of heavy plant over a period of ten years. Amendments to the Replacement Program are made in consultation with the Heavy Plant Review Committee (HPRC) prior to consideration by the Council.

STATUTORY ENVIRONMENT

Local Government Act 1995

EXTERNAL CONSULTATION

Suppliers of heavy plant have been contacted for pricing information as required.

FINANCIAL IMPLICATIONS

At the Council Meeting of 22 June 2021, it was resolved that a base amount be maintained in the Plant Replacement Reserve account of \$500,000.00 which is intended to cover the replacement of up to two heavy items of plant in the event of a catastrophic failure. An annual allocation of \$550,000.00 will be added to the Reserve account to fund plant purchases. At the conclusion of the financial year, the Reserve account will be reviewed and any unspent funds over the \$500,000.00 base fund can be presented to the Council for reallocation.

Expenditure on replacement machinery has been as balanced as possible to keep within the imposed caps noting that small over expenditures may occur in 2025/2026, 2027/2028 and 2032/2033.

All pricing on acquisition and disposal are based on the most recent pricing available and are expressed in today's values without allowance for inflation or other market changes.

BUDGET IMPLICATIONS

There are no particular implications as this plan aligns with previous HPRP.

POLICY IMPLICATIONS

The draft program as presented provides for balanced acquisition and disposal as per Council Policy I/PM/1 Plant – General last reviewed on 20 December 2022.

STRATEGIC IMPLICATIONS

The Shire of Plantagenet Corporate Business Plan 2022/2023 – 2025/2026 provides:

This HPRP provides for sensible acquisition and disposal of heavy plant in accordance with the current needs of the Shire. It aligns with Council policy on the timing of disposals and Council resolution for the management of the Heavy Plant Reserve.

That it be a recommendation by the Heavy Plant Review Committee to the Council that the Heavy Plant Replacement Program 2023/2024 be adopted for inclusion in the 2023/2024 budget.

That it be a recommendation to the Council that:

- 1. The Heavy Plant Replacement Program as presented, be endorsed, with the exception that the replacement of the CAT 12M Grader (PL02) be listed for replacement in 2024/2025 instead of 2023/2024.
- 2. A minimal sum be included in the 2023/2024 for transfer to the Plant Replacement Reserve which brings the balance of the Plant Replacement Reserve to approximately \$500,000.00 to allow for catastrophic breakdowns and plant replacement opportunities.
