I am currently reviewing the Local Emergency Management Arrangements and with the kind help of Neville Blackburn and the Department of Child Protection and Family Services the Evacuation section has been completed and hope to have the LEMC endorse them at this meeting. The next section I will be addressing are the Recovery Arrangements and hope to have them for viewing at the next meeting of the LEMC committee.

Mock Incident

The next mock incident to test the capabilities of the LEMC will be a table top exercise; the members from the hospital have kindly offered to present an incident that they may be presented with at any time. It will be the type of incident that the majority of the LEMC would not be primary responders. This will give other members of the LEMC a chance to enhance their knowledge of working as an Incident Support Group.

MOUNT BARKER VOLUNTEER FIRE AND RESCUE

WEST AUSTRALIAN POLICE

Sgt Al Keogh reported that there were four serious before Easter but the Easter period it self was quite.

As a matter of interest he informed the committee that on the Thursday 7200 passed through Mt Barker along Albany Highway.

MOUNT BARKER STATE EMERGENCY SERVICE

Kirsten Beidatsch introduced herself as the new manager of the Mount Barker State Emergency Service Unit.

The Unit had not received any calls for assistance since the last LEMC meeting but with the winter months approaching this could change.

BUSH FIRE SERVICE

Murray Wills the acting Chief Bush Fire Control Officer informed the committee of the accident to Kevin Forbes in late March.

Due to a number of escaped permit burns and weather conditions it has been decided to extend the restricted burning time within the Shire of Plantagenet. Since the last committee meeting it has been reasonably quite.

<u>Community Emergency Management Officer – State Emergency</u> <u>Management Committee</u>

Adam Smith discussed the results of the resilience survey for the community of Kendenup that was completed at the last LEMC meeting. Done as a table top exercise the results showed a low resilience level, this could change if done with members of that community.

Department of Child Protection and Family Support

Neville Blackburn informed the committee that the attached Provision of Welfare Support had been reviewed and updated to reflect the current contact information in regards to evacuation centres and resources. This document would be the primary resource for the Department of Child Protection and Family Support if needed and assist in staff training.
