#### <u>Amalgamation of Emergency Services Legislation</u>

The DFES is reviewing the emergency services legislation to develop a single comprehensive Emergency Services Act. It is proposed to amalgamate the *Fire Brigades Act 1942*, the *Bush Fires Act 1954* and the *Fire and Emergency Services Act 1998*.

The Shire made a submission to the Legislation Review Team which included the need to ensure protection for volunteers, to retain bush fire brigade services with Local Government and to enable Local Government's the ability to declare an area indefensible.

#### 5 GENERAL BUSINESS / MATTERS ARISING

#### Mount Barker Volunteer Fire and Rescue Service

The Brigade has had a relatively quiet year with little to report. The Annual General meeting is scheduled for June 2013.

#### West Australian Police

Most activity has been crime related, with little to report regarding emergency management activities.

#### Department of Fire and Emergency Services (DFES)

A reminder that the LEMC Annual Report is due on 15 July 2013.

#### State Emergency Service (SES)

A quiet time for the service. Training in the use of abseiling/cliff rescue equipment ongoing. The Albany SES unit did a 'Roof Top Rescue' demonstration off the Mount Barker Recreation Centre roof during the April 'Have a Go' Expo.

#### **Bush Fire Service**

A relatively quiet summer. The biggest fire incident was at Pugh Rd involving the Mount Barker Volunteer Fire Rescue Service, DFES, Police, plantation companies, water bombers and 20 appliances.

#### St John Ambulance

Averaging 40 jobs per month. A new ambulance will be delivered to the Mount Barker Centre within the coming week, bringing the number of ambulances in the Shire to four in Mount Barker and one in Kendenup. The RAC Helicopter was used to airlift a patient, landing at Sounness Park.

#### Department of Environment and Conservation (DEC)

DEC has a new burning approval process in place which is quite comprehensive and takes considerable time. The agency may be separated into two agencies – the regulatory side and the conservation side.

#### Mock Incident

A LEMC mock incident is being planned, to be held at the Mount Barker Community College. Proposed date is 1 June 2013. Jeff Drage and Sgt Al Keogh to progress the plans for the event, with Joanne Weekes (new Community Emergency Services Manager) to assist when she is available.

#### Use of Volunteer Stickers on Vehicles

Some Shires have implemented a 'volunteer sticker' which goes on vehicles and can enable people access through road closures. The Cranbrook Bush Fire Service is considering the strategy. John Tonkin, DFES, is sourcing some information regarding the stickers and implementation of the stickers.

Action: Joanne Weekes to follow up the sticker information from John Tonkin and provide the information for consideration at the next LEMC.

#### Bush Fire Service interaction with WA Police

Murray Wills spoke of the need to meet with the local Police Service prior to the fire season to do a 'meet and greet' and work through strategies involving road closures, communications etc.

Action: Joanne Weekes to organise a meeting in the lead into the 2013/2014 fire season.

#### LEMC Arrangements

The LEMC Arrangements and contact lists are due for review.

Action: Joanne Weekes to progress an update of the arrangements and liaise with Sgt Al Keogh regarding an update to the contact lists.

#### SEMC Policy 4.4

SEMC Recovery policy is being reviewed and comments sought. A copy is attached to the minutes for the LEMC's consideration. Please forward any comments to Joanne Weekes.

#### **Test Recovery Processes**

The need to test the LEMC's Recovery Process was discussed.

Action: Adam Smith to organise a 'Recovery' scenario for the August LEMC meeting, using the LEMC Mock Incident held in June as the scenario.
