#### 5.4 FUNDING NOMINATIONS AND APPLICATION PROGRESS

Animal Welfare in Emergencies Grant for Local Governments (Attachment Two)

Shire

Applying for animal troughs at Frost Park, and

A permanent stand pipe for stock water at Frost Park

This area, in emergencies, would only be for pets, as they are not permitted in welfare shelters.

The Park can house approximately 200 Horses.

Department of Fire and Emergency Services (DFES) have granted the Shire \$55,000 to reduce fuel loads on the Unallocated Crown Land (UCL) and Unmanaged Reserves (UMR) within the gazetted town sites of Mount Barker, Kendenup, Narrikup and Rocky Gully.

Through the Local Governments Grant Scheme (LGGS) we have received nineteen Automatic External Defibrillators (AED's), to be placed on each bush fire appliance and the State Emergency Service storm Truck.

#### 6.1 SHIRE OF PLANTAGENET

The Bushfire Resilience In Great Southern (B.R.I.G.S.) project will be holding two community consultation meetings;

One in Kendenup, on Tuesday 4 August. This will encompass the gazetted town site of Kendenup.

One at the Community Resource Centre (CRC) 6 August. This will encompass the Mount Barker Hill subdivision.

The final report will be due at the end of April 2021

#### 6.5 ST JOHN AMBULANCE

6.5.1 Community Paramedic

There has been a contingent of Western Australian paramedics arrive in Victoria to assist with their second wave of the COVID 19 virus. (the virus)

Plans have been updated in preparation for a second wave of the virus here in Western Australia.

Personal Protective Equipment is in good supply approximately three months' worth.

6.5.2 Mount Barker Sub-Centre

First aid training has recommenced at the Mount Barker Sub centre. An increase of equipment means there is no need for students to share and limits the contact of individuals.

Ambulance calls have been down for the months of April, May and June. This is in line with the number of calls for the metro. Eighty percent of the calls received have resulted in the patient being transported to the Albany Regional Hospital due to a low number of doctors currently at the Mount Barker hospital.

6.5.3 Rocky Gully Sub-Centre

A concept plan is underway to extend the training facility with expressions of interest for a builder being sought.

#### 6.6 STATE EMERGENCY SERVICE

Three call outs due to the last storm event, including delivery of sand bags to the Albany unit from the state equipment cache.

The Truck is currently experiencing difficulties and keeps going into limp mode. It is with the mechanic in Albany being looked at.

DFES are looking into acquiring a second vehicle for use with the storm cache equipment.

Improvements to the Unit training building will be starting with a ramp and easy access door.

Forensic search training has been completed with the joint efforts of Western Australian Police Force in Mount Barker, the University of Western Australia in Albany, images from the Durham University in the UK and one of our qualified members.

#### <u>Question</u>

What if the emergency is biosecurity based?

<u>Answer</u>

All of the biosecurity plans are in place with high emphasis on the amount of animal produce that comes from this area.

Currently five incidents within the state; three are in Perth, one in the Kimberly and on state wide with ants.

Victoria is experiencing chicken influenza this is being closely monitored as there is a risk to the Western Australian producers.

6.11.1 Albany District

DBCA would like to see collaboration with the other shires around the timings of the LEMC meetings. i.e. having these meetings at a similar period but at different times with time to travel will increase the attendance of the majority of persons who need to attend more than one LEMC meeting each quarter.

There has been extensive recovery with the Stirlings National Park after the fires with still more to do.

The new walk trail has proven to be successful and well used.

New funding arrangements will lead to new upgrades within the Porongurup National Park, specifically the cark parks and base areas.

Burning programme with include the Unallocated Crown Land (UCL) around the Porongurup National Park.

Funding through the Mitigation Activity Fund (MAF) has been received for the up keep of the reserves.

PPE is limited at the moment with increasing supplies coming weekly.

There are currently four members in the Mount Barker group, with two new members hopefully coming on board shortly.

Training will be an issue as the Perth based training this has been suspended for the time being.

#### 6.15 WATER CORPORATION

Bush fire protections zones for our assets are being planned and will be carried out shortly.

Water carting is still on going to several regions within the Great Southern.

The water pipeline to Denmark from Albany is progressing well.

Good supply of PPE and plans in place for a second wave of the COVID 19 virus.

#### 6.16 MAIN ROADS WESTERN AUSTRALIA

The recent storm events have led to isolated flooding of roads around the area.

Construction planning is underway

Funding has been received for shoulder strengthening and the Road Safety Program 'RoadWise.'

The bushfire asset protection preparation is well ahead of schedule.

There will be a road closure on Southwest Coastal Highway due to upgrades. Construction will commence in January 2021.

Combined Bulk Handlers (CBH) are been consulted with some issues to work through together.

Road traffic management plans will be in place with a 25km detour around the road works.
