#### 5 REPORTS OF COMMITTEE MEMBERS AND OFFICERS

#### 5.1 LIGHTING OF TOWER ON MOUNT BARKER HILL

#### **Electrical Lighting Design**

A quote to develop a concept plan and cost estimate for lighting the tower has been received (\$4,400.00 + GST).

#### OFFICER'S RECOMMENDATION/COMMITTEE DECISION

Moved Cr S Etherington, seconded Cr J Oldfield:

That it be a recommendation to the Council:

#### That:

- 1. A lighting concept plan at a cost of \$4,400.00 + GST be developed for the Mount Barker Hill
- 2. The funds be made available from the trails review budget.

#### 5.2 MOUNT BARKER HILL - MTB TRAILS (GSCORE)

GSCORE has initiated the flora, fauna and dieback surveys (total cost approx. \$17,000.00 + GST). These surveys are currently underway.

At this stage Aboriginal consultation will take place with the local Noongar families prior to any wider consultation being proposed.

GSCORE has also developed a project brief for obtaining quotes from trail designers to undertake the concept planning of the mountain bike (MTB) trails. GSCORE would like the Mount Barker Hill Advisory Group to review the quotes (possibly on 24 or 25 March) and later attend a start-up meeting with the trail designer (possibly the following week).

#### OFFICER'S RECOMMENDATION/COMMITTEE DECISION

Moved Cr J Oldfield, seconded Cr K Clements:

That the opportunity to continue to work with GSCORE as a control group developing the mountain bike trail plan for Mount Barker Hill be welcomed.

#### 5.3 MOUNT BARKER HILL CONCEPT PLAN (GSCORE)

The GSCORE brief only refers to MTB trails. The Shire of Plantagenet will have to engage a landscape architect to develop concept plans.

GSCORE will include the 2011/12 Peter Duncan concept plan in the brief but no further work will be undertaken by the trail designer. It is important that these the concept plan and trails plans are integrated.

Further discussion indicated that the lighting of the tower was the priority and that the scope of items to include in the concept plans includes:

- (a) Tower lighting;
- (b) Adequate parking for cars (50 spaces) and long vehicles/ buses (2 of);
- (c) An additional observation platform to be located to the south west, looking towards Denmark. This observation platform would be also used by astronomers:
- (d) A boardwalk connecting lookouts;
- (e) Toilets as appropriate including universal access toilets;
- (f) Road loop on the hill should be one way;
- (g) Pathways to be lit by solar lights; and
- (h) The area behind the tower could be used for overflow parking.

#### OFFICER'S RECOMMENDATION/COMMITTEE DECISION

#### That:

- The CEO be requested to obtain quotes to undertake the landscape concept planning for the landscape component of the Mount Barker Hill Concept Plan, excluding the mountain bike trails.
- 2. A budget estimate be developed to undertake the concept planning for inclusion in the draft 2020/21 budget.
