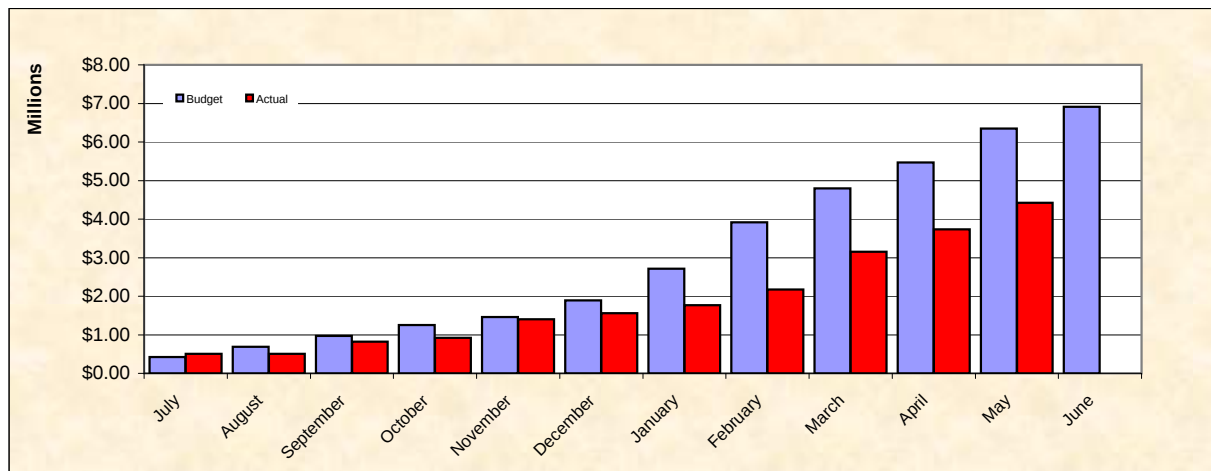
Basis of the Report

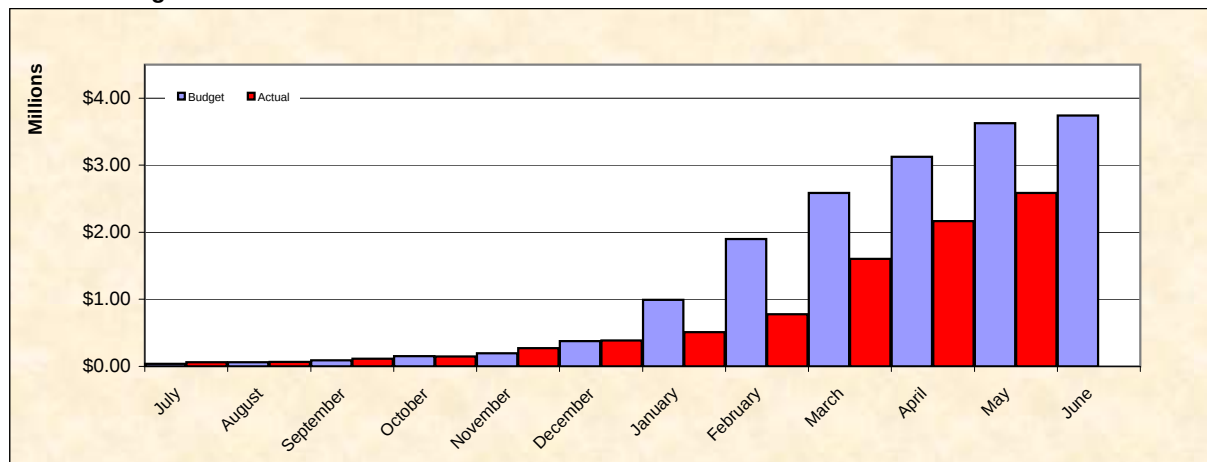

All Capital Projects



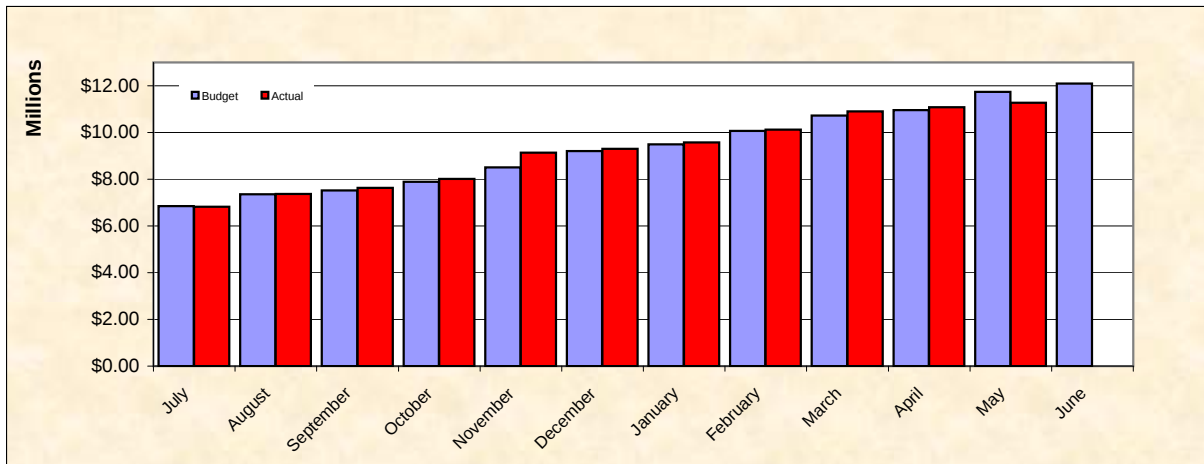
Capital outlays are currently running 29.7% under budget.

Roadworks Program



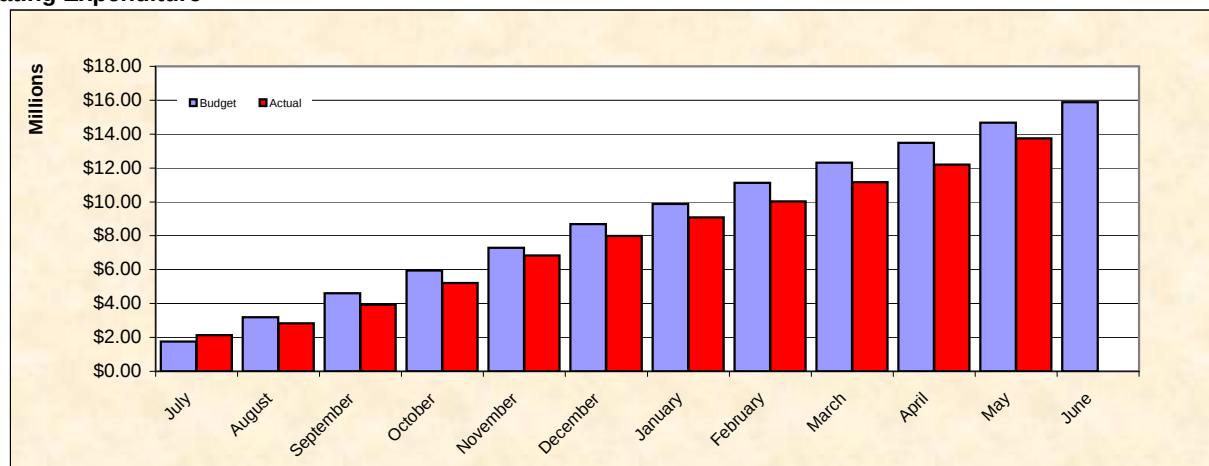
The roadworks program is currently running 28.6% under budget.

Operating Income



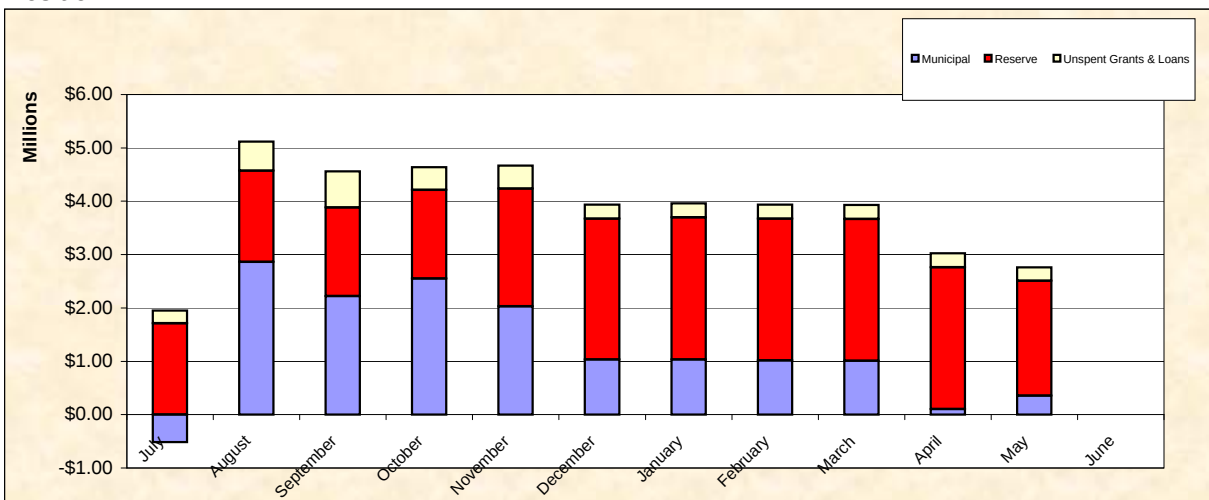
Operating income is currently running 3.9% under budget.

Operating Expenditure

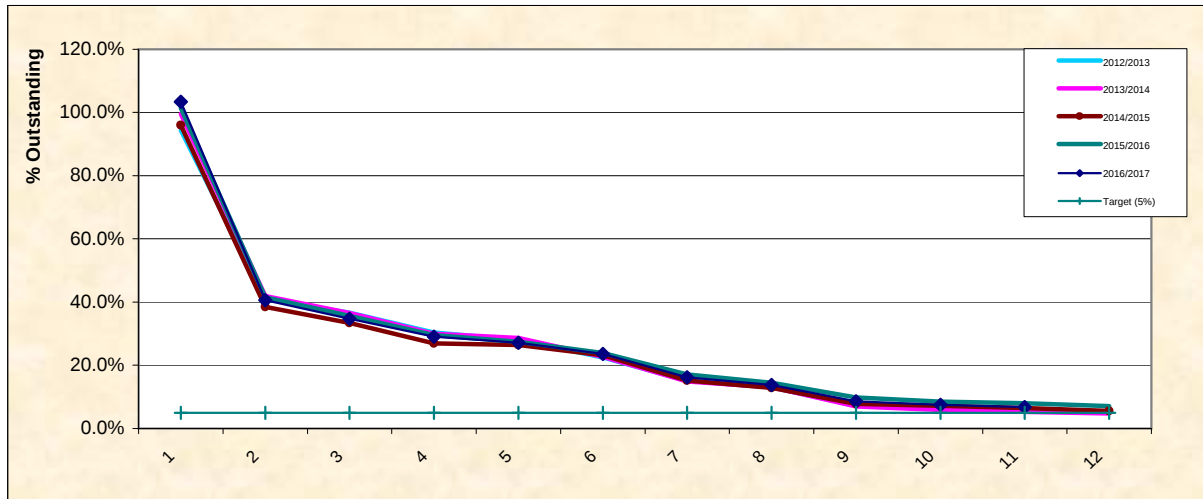


Operating Expenditure is currently running 6.23% under budget.
