#### SCHEDULE - SCOPE OF WORK, BUDGET AND SPECIAL CONDITIONS

#### ITEM A: RESEARCH PROJECT DESCRIPTION AND REPORTING/DELIVERABLES

#### 1. Background

The Shire of Plantagenet operates a wastewater treatment plant associated with the operations of the Mount Barker Regional Saleyards (MBRS). There are two parallel facultative waste stabilisation ponds (WSPs) followed by one maturation pond. The WSPs receive a moderate amount of solids from wash down of the saleyard pens and an onsite truck wash. Efforts to remove a large amount of solids before entering the ponds has been largely unsuccessful, and the performance of the ponds is deteriorating as sludge continues to accumulate in ponds. The Shire has been presented with several options for improving treatment, but would like to explore this further before committing to expensive capital works, and would also like to explore more reuse options for the treated water.

#### **RESEARCH - GENERAL CONDITIONS**

#### 1. RESEARCH TERMS

- (a) UWA will commence the Research Project upon the Commencement Date or as soon as reasonably possible thereafter and will complete the research on the Completion Date or as soon as practicable thereafter.
- (b) UWA will carry out the Research Project in the manner set out in the Schedule.
- (c) All research work shall be performed with due skill and diligence to UWA's professional standards.
- (d) All research work will be carried out by the specified personnel in Item C of the Schedule. If the specified personnel cease to be associated with UWA or otherwise become unavailable to direct this project, UWA will be entitled to replace the specified personnel with a qualified researcher acceptable to the Sponsor.

#### 2. INTELLECTUAL PROPERTY RIGHTS

- (a) Pre-existing intellectual property supplied for use in the Research Project by a party will remain with that party. Sponsor grants UWA a royalty free, non-exclusive licence to use its pre-existing intellectual property solely for the purpose of performing the Research Project.

(h) Any samples provided by the Sponsor that are unused at the end of this project will be returned to the Sponsor within thirty (30) days of the Sponsor's request to do so.

#### 4. DUTIES AND RESPONSIBILITIES

- (a) The Sponsor must on or before the Commencement Date or failing that, as soon as reasonably possible:
  - provide all information, documents and other particulars relating to the Sponsor's requirements for the Research Project;
  - supply further information requested by UWA and relating to the Research Project.
- (b) The parties must co-operate with each other to enable the proper performance of the Research Project.
- (c) The Sponsor acknowledges that the Research Project's success is dependent upon the timing, quality and quantity of the information provided to UWA.
- (d) The Sponsor must pay the cost of all taxes, levies and duties of any nature whatsoever required in respect of this Agreement.

#### 5. WARRANTIES AND REPRESENTATIONS

- (a) Use of the results shall be solely at the Sponsor's own discretion and risk and UWA shall not be liable for any damage resulting from any inaccuracy, incorrectness, unsoundness and/or unreliability in its use.
- (b) The results are provided without any representation or warranty of any kind, either express or implied, including but not limited to being of satisfactory quality or fitness for a particular purpose.

#### 6. REPORTS

(a) UWA will provide the Sponsor with reports or deliverables as described in Item A of the Schedule.

# 7. PUBLICATION AND CONFIDENTIALITY

Unless otherwise specified in the Schedule:

- (a) UWA hereby undertakes to consider all information (whether oral or written) provided by Sponsor as confidential, provided that such information is specified at the time to be confidential.
- (b) UWA (including its staff and students) may freely publish technical articles, make oral presentations, and publish theses concerning the Research Project, experimentation and data obtained in performing the Research Project.
- (c) UWA will not include the Sponsor's confidential information, or use the Sponsor's name in any publication referred to in 7(b) above without the Sponsor's consent.
- (d) The Sponsor acknowledges that UWA is legally obliged to ensure that any student involved in the project is able to complete the requirements of their candidature, and that this obligation extends to submitting the student's thesis for examination and depositing in the library a copy of the student's completed thesis or work submitted for a higher degree. The thesis may, upon request by the Sponsor, be placed on restricted access for a period of up to twelve (12) months.

#### 9. INABILITY TO PERFORM AND LIABILITY

- (a) UWA will not be responsible for the consequences of failure to perform its obligations under this Agreement if this failure results from events beyond its reasonable control.
- (b) The liability of UWA to the Sponsor in respect of its negligent acts or omissions in performing the Research Project shall be limited to the cost of re-performing the Research Project or the sum of the funding, whichever is the lesser.
- (c) UWA's liability is as set out in this condition and UWA shall have no liability for any other loss or damage including (without limitation) loss of revenue, loss of profits, loss of use, and loss of contracts.
- (d) No statements or representations made or information supplied by UWA shall form part of this Agreement unless specifically incorporated.
- (e) UWA makes no representations or warranties regarding the research outcomes including merchantability or fitness for a particular purpose or that use of the research outcomes will not infringe any intellectual property rights or other rights of any person.

- (b) Each party will be obliged to furnish to the other party a certificate of currency and renewals of such insurances if requested to do so.

### 11. OCCUPATIONAL HEALTH AND SAFETY

- (a) To the extent that the Sponsor's employees, agents, contractors or students (Personnel) use UWA's premises or facilities, the Sponsor must ensure that each such Personnel:
  - fully cooperates with UWA on all matters relating to occupational health and safety;

#### ii. complies with:

- all applicable occupational or workplace health and safety laws and any regulations, guidelines or codes of practice made under or in connection with such laws (OHS Laws); and
- all rules, directions and procedures relating to health and safety of which the Sponsor or Personnel is advised, except to the extent that they are inconsistent with OHS Laws; and
- promptly notifies UWA of any accident or injury that occurs when using UWA's premises or facilities.

- (a) If UWA is prevented or cannot perform the Research Project by reason of an event beyond its reasonable control for a period exceeding one month, either party may terminate this Agreement, by giving fifteen (15) days' notice to the other.
- (b) A party may terminate this Agreement immediately on written notice to the other, if the other party materially breaches this Agreement, goes insolvent or conducts itself in a manner which, in the party's opinion (acting reasonably) has or is likely to have a material adverse effect on the terminating party's name, reputation or business.
- (c) Any notice or other communication required to be given under this Agreement will be in writing to the facsimile, email or physical addresses set out on the front page of this Agreement.

#### 13. GENERAL
