#### **PURPOSE**

The purpose of this report is to recommend the attendance of a Councillor at the 2023 National Local Roads, Transport & Infrastructure Congress. The event is scheduled to be held in Canberra from 6-7 September 2023.

#### **BACKGROUND**

Organised by the Australian Local Government Association (ALGA), the National Local Roads, Transport & Infrastructure Congress is held annually. Crs Handasyde and Bell attended the conference in Albany in 2017.

#### **EXTERNAL CONSULTATION**

No external consultation has occurred in relation to this report.

#### STATUTORY ENVIRONMENT

There are no statutory implications for this report.

#### FINANCIAL IMPLICATIONS

The cost of early registration for the two-day conference is \$895.00 (early bird price to 4 August 2023), which covers the Welcome Reception, all conference sessions (morning tea, lunch and afternoon tea) and the Congress Dinner on Wednesday 6 September.

Flights, accommodation, transport and meal costs for attendance at the Congress are estimated to be in the vicinity of \$3,000.00, with costs to be charged to account Members of Council – Councillor Conferences, Training and Accommodation.

#### **BUDGET IMPLICATIONS**

Budget item 2040104 (Members Training & Development) and 2040109 (Members Travel & Accommodation) may be used for this purpose. The combined budget for this being \$33,000.00, of which estimates of \$18,395.00 have been committed to-date.

#### **OFFICER COMMENT**

The theme of this year's Congress is "Building Communities that are safer, stronger, smarter". The content will be centred on practical takeaways, with successful council projects from around the country showcased, as well as opportunities to hear from leading experts across the key areas of roads, transport and related infrastructure, including community infrastructure. Interact with policy and grant program leads from federal government agencies and have your questions answered; and learn about the latest trends and developments in road safety, circular economy, decarbonising infrastructure builds, telecommunications, and technology.

Local roads funding, heavy vehicle access, road safety and affordable housing will be covered, but will also include a broader focus on community infrastructure including waste and recycling, disaster mitigation, and renewable energy.

Importantly, this year's Congress will be held in Canberra during a Parliamentary sitting week, providing an opportunity to engage with federal members and other key decision makers.

Cr Handasyde is the Chair of the Great Southern Regional Road Group, with Cr Oldfield being the Council's representative on the Regional Road Group Committee. Cr Pavlovich is the deputy member of the Regional Road Group Committee, State Councillor and Chair of the WALGA Infrastructure team.

Although we have had no delegates attend this conference since 2017, feedback from consistent attendance previously has always been very positive.

The Acting Manager Works and Services intends to seek authority from the Chief Executive Officer to attend this conference.
