5 MOUNT BARKER MEMORIAL SWIMMING POOL - FEASIBILITY STUDY - REQUEST FOR QUOTE

The Manager Development Services has prepared a Draft Request for Quotation (RFQ) to obtain the services of a suitable consultant to prepare a 'Swimming Pool Redevelopment Feasibility Study' in accordance with Council resolution 35/19. The Draft RFQ was reviewed by the Committee with the following points noted:

- a. The proposed selection criteria will include a 30% weighting on relevant experience and project resourcing, and 20% on the approach as proposed by the responder;
- b. Funding could be sought from Round 2 of the Community Sporting and Recreation Facilities Fund which opens in July and closes in August 2019. If grant funds are applied for to conduct the report then the commissioning of the study would need to be delayed until the additional funds are confirmed;
- c. The City of Albany has not declared that it has a plan to build a 50m pool;
- d. The requirement to look at alternative sites for a swimming pool should include, but not be limited to, the Community College and Sounness park;
- e. The *financial viability* criteria should include an analysis of capital cost, servicing cost and operating costs;
- f. The initiative to conduct a feasibility study was driven by the desire to see an appropriate long term solution developed for the Mount Barker Memorial Swimming Pool and that the pool was used by groups from outside Plantagenet and acted as a regional facility
- g. The Project Group should consist of two members of the Recreation Advisory Committee, two community members, Manager Development Services, and Manager Swimming Pool with the group chaired by the Manager Development Services;
- Existing swimming pool reports should be included as reference material in the RFQ or provided once the consultant has been appointed;
- The RFQ would be conducted on WALGA eQuotes and individual appropriate firms would be notified that the RFQ was being conducted.

That the intention of the CEO to advertise the Request for Quote relating to the Mount Barker Memorial Swimming Pool feasibility study as attached be noted, acknowledging that the CEO has amended the:

9 REGIONAL TRAILS MASTERPLAN

The Great Southern Centre for Outdoor Excellence (GSCORE) is preparing a Regional Trails Masterplan. As part of this process GSCORE is conducting consultation workshops in the LGAs of the Great Southern. Three workshops have been conducted in the Shire of Plantagenet. These have been well attended with a number of new trail proposals put forward in addition to the trails included in the Plantagenet Trails Masterplan 2006. The trails proposals include trails for walking, hiking, mountain bike, horse riding, road cycling, driving, heritage and others. The Committee believes it would be opportune for the Shire to form a working group to review the Plantagenet Trails Masterplan 2006, investigate new trails proposals and assist the Committee make appropriate recommendations to Council.
