The previous meeting was a Planning Workshop. Outcomes are attached.

4 RECREATION CENTRE STAFF RESTRUCTURE

The staff structure across the Mount Barker Swimming Pool and Recreation Centre has been amended to maximise the use of recreation staff and to address the salary budget for both cost centres. Ronnie Smith has been employed as the full time Recreation Centre coordinator. Zac Hambley is now working in a full time role which will see a majority of his time spent at the Pool and fewer hours at the Recreation Centre. Over the summer period a part time person will be engaged at the Recreation Centre to assist Ronnie.

Ronnie has held management roles in private and government operated Recreation Centres. She has been involved in program development across a number of different activities and is accredited to run a wide range of classes and programs.

5 RECREATION CENTRE BUSINESS PLAN

The current Recreation Centre program timetable is attached. The following activities are also being considered:

- A promotional Open Day;
- After School Care (to be managed by the YMCA) consideration to be given to the interaction with children not involved in the After School Care program that may be present in the Centre and an understanding of what resources and equipment are available for After School Care needs to be clarified with the Care Providers:
- External gym access to enable the use of the gym outside of normal Recreation Centre hours by members – consideration to be given to a single line telephone to use in the event of an emergency, a lock on the door between the gymnasium and the remainder of the Centre and accessible hours during the evenings and weekends to avoid the area becoming a socialising place rather than a gymnasium; and
- A Home Schooled Kids Program.

Other classes that will be investigated are Youth Programs such as Girls Power and Boys Fit, Executive Health and the expansion of the Tai Chi classes.

The current food and beverage range in the kiosk will also be expanded to provide more a café environment. Further consideration will be given to the layout of the kiosk area to make it more welcoming, encouraging people to stay in the Centre and use more of the facilities.

These initiatives have been identified in the Recreation Centre Business Plan which has been prepared by the Committee and staff.

Action:

Nicole Selesnew to forward a copy of the Recreation Centre Business Plan to all Committee members.

Ronnie Smith to liaise with Andrew Fraser regarding future classes to ensure there are no clashes with the 2010 Recreation Centre timetable. The timetable is set in November.

6 REVIEW OF THE RECREATION CENTRE AGREEMENT

The Shire of Plantagenet is going to revisit the Recreation Centre Agreement with the aim of clarifying which party is responsible for maintenance and capital alterations to the building following some uncertainty between the Shire and Department of Education. The Shire is willing to consider a lease rather than a licence to further clarify the role of each party within the agreement.

Action:

Rob Stewart and Nicole Selesnew to progress with the Department of Education.
