#### 4 RECREATION PRECINCT PLANS – IMPLEMENTATION TIMELINE AND SCHEDULE OF FUNDING SOURCES

The Committee debated different development options for the Sounness Park precinct area including the temporary collocation of the Sounness Park clubrooms with the Mount Barker Bowling and Sports Club.

At the conclusion of discussions it was agreed that the focus remain on the adopted Frost and Sounness Park Sport and Recreation Precinct Development Plan and that the initial areas for development be the:

- Sounness Park clubrooms / changerooms;
- Realignment and improvements to the Sounness Park oval; and
- Installation of the new soccer and cricket pitches.

#### Action:

Rob Stewart and Nicole Selesnew to prepare a draft Sport and Recreation Development Plan to present to the next meeting.

#### 5 MANAGEMENT OPTIONS FOR THE SOUNNESS PARK SPORT AND RECREATION PRECINCT

A range of different sport and recreation precinct management options implemented in other Shires were presented for consideration (see attached).

The Committee discussed the different options and agreed to defer the conversation until the Development Plan was complete.

#### 6 GENERAL BUSINESS

The Committee identified the need to re-establish communication with Racing and Wagering Western Australia (the governing body for racing) in relation to the endorsed precinct plan for Frost Park.

A valuation has been ordered for the land adjacent to Sounness Park commonly referred to as Demon Downs. Once received, the Shire will be in a position to start negotiating a purchase with the Football Club to enable the progression of the Sport and Recreation plans.
