#### 5.2 SAFE ROAD USE

#### 5.2.1 MEDIA PROMOTING ROAD RULES

Cr Bell discussed the proposal to use the media to highlight road rules and the penalties that apply.

After some discussion it was agreed that Ms Gardiner would look at providing some messages for the Shire Facebook page that would tie in with the focus of local police on five key road issues as follows:

- 1. Impaired driving (drink driving and drug driving);
- 2. Use of mobile phones;
- 3. Speed;
- 4. Seatbelts; and
- 5. Fatigue.

Action: Mr Gardiner be requested to work with the Shire's Communications Officer to address the five issues prioritised by local police and align them with relevant road safety campaigns.

#### 5.2.2 VEHICLE CHECK - SERVICE

Cr Bell reported that he had spoken with local car service businesses about the idea of running a vehicle safety check. The businesses were positive about it and offered the service of a mechanic during business hours.

The possibility of including a tyre change demonstration as part of the service was also discussed.

It was agreed that the sealed area behind the Mount Barker Town Fire Station would be appropriate and that Wednesday 23 March was a suitable date. Two sessions were suggested from 10am to 12 noon and then 1pm to 3pm.

Action: Cr Bell advised he would confirm the availability of mechanics for the event.

#### 5.2.3 DRIVER REVIVER - FRIDAY 4 MARCH 2022

The committee discussed the following points for the upcoming Driver Reviver event to be held at the Tenterden Top-Up site on Albany Highway.

- Event to start at 12 noon and finish when volunteers on site decide that demand was negligible.
- Mrs Drage confirmed she is organising the roster and stated she had St John Ambulance representatives and fire brigade volunteers.
- Portable toilet this has been ordered and Cr Bell advised he would deliver the toilet to the site.

 Brad Lenton advised that Main Roads would supply the light and VMBs and would deliver to the site and also collect after the event.

The committee discussed the risk of COVID-19 and Ms Gardiner advised she would obtain the WALGA perspective on holding events at this time. If WALGA advised that the risk was too great and recommended the event not be held the Committee would discuss outside the meeting.

#### 5.2.4 BLESSING OF THE ROADS 2022

The committee agreed the event would be postponed and possibly held later in the year due to projections indicating that COVID-19 would be at its peak in Western Australia in April 2022.

#### 5.3 SAFE ROADS AND ROADSIDES

#### 5.3.1 CLASS 1 REFLECTIVE SIGNS

Brad Lenton advised that Main Roads WA had positioned the signs at the appropriate angle and that motorists should dim their lights on approach.

#### **6 AGENCY REPORTS**

#### 6.1 ROADWISE

Ms Gardiner spoke to the report at Attachment One and pointed out the types of crashes in the Great Southern. She also highlighted the road safety benefits of road shoulder sealing and the installation of audible edge lines.

Ms Gardiner also referred to the Road Safety grants/funding available.

#### 6.2 MAIN ROADS WA

Mr Lenton mentioned the two fatal crashes on Shire of Plantagenet Roads this financial year and that both were due to driver error rather than the condition of the road.

He highlighted the roadworks scheduled for Albany Highway in the Great Southern, in particular the roadworks north of Cranbrook where lots of traffic management is in place.

#### 6.3 MOUNT BARKER POLICE

Snr Constable Somerville reported on the busy roads in the Shire over the Christmas holiday period. Despite this the number of infringements were not high.

#### 6.4 SHIRE OF PLANTAGENET

Mr Lynch reported on the shoulder sealing soon to start on Woogenellup Road. The entire road is to have the shoulders sealed and audible edge lines installed.

#### 6.5 MOUNT BARKER COMMUNITY COLLEGE

Ms Hughes reported that parents are not allowed out of their vehicles at school (due to COVID-19 restrictions) which is making for challenging drop off and pick up times.

#### 6.6 COMMUNITY MEMBER

Mrs Drage highlighted motorists parking near the BankWest ATM when taking money from the machine. Mr Lynch explained that bays can be marked but there is no method of enforcement until Council approval is obtained for regulating parking at this area.



## **WALGA RoadWise**

Road Safety Report – Great Southern February 2022



Around 20 percent of WA's population live in regional areas such as the Great Southern, however regional WA accounts for approximately 40 percent of people killed or seriously injured on our roads.<sup>1</sup> The following table highlights the types of crashes that resulted in 155 people being killed or seriously injured (KSI) in the Great Southern between 2014-2018.<sup>2</sup>

Single vehicle run-off crashes continue to be the most common type of road crash in regional areas, including the Great Southern. Three in every four serious crashes on regional Western Australia roads also involved a local driver either within their own Local Government area or an adjacent one.<sup>3</sup>

Crash insights reveal that 55 percent of rural crashes are on roads of 110km/h and often involve the vehicle running off the road and hitting an object such as a tree.<sup>2</sup>

The sealing of road shoulders and installation of audible edge and centre lines on a number of WA's rural roads has reduced severe and casualty crash rates by 58% and 80% respectively.<sup>2</sup>

#### **Road Safety Management System**

The Road Safety Management System (RSMS) is a new service for Local Governments developed by WALGA's RoadWise Program.

Local Governments have a strategic and operational role in road safety as road managers, road system designers, planning authorities and fleet managers, in addition to their community development and leadership roles.

The aim of RSMS is to provide strategic advice and practical support to Local Governments to systematically manage local road safety performance with the long-term goal of eliminating death and serious injury on the local road network.

#### CASE EXAMPLE: Wheatbelt Local Government Road Safety Audit Project

The Shire of Toodyay received a Road Safety Community Grant to upskill Local Government staff as a panel of trainee auditors for the Avon Valley. Staff from the four participating Local Governments completed the Institute of Public Works Engineering Australasia Western Australia online Road Safety Audit course. This was followed by a workshop facilitated by Shawmac Senior Auditors, Richard Jois and Damir Vagaja.

The workshop included presentations on the safe system, case study discussions, crash types and suitable countermeasures, and the importance of data analysis. Sharing knowledge and expertise in the workshop format allowed Local Governments to identify problem locations and prioritise their treatment - for example, run-off road crashes are the priority crash type requiring treatment in the Wheatbelt.

The project was funded through a Road Safety Community Grant.

# Road Safety Community Project Grants are available up to \$25,000 and can run for 12 months. The current round closes on 31 March 2022
