5 REPORTS OF COMMITTEE MEMBERS AND OFFICERS

5.1 SAFE SPEEDS

5.1.1 SPEED INDICATION DEVICES

The Committee discussed the SID positioned in various locations. Currently the signs are located on Lowood Road near Plantagenet Sheds; Rocky Gully; Ormond Road; and Langton Road. Beverley Road was put forward as a possible future location.

Mr Hemmings advised that no data was being downloaded from the SIDs at the moment due to Shire staff having other priorities.

5.2 SAFE ROAD USE

5.2.1 DRIVER REVIVER

The Committee discussed the Driver Reviver event held on Friday 22 September at the Tenterden Store on Albany Highway. See Attachment One.

The following comments were noted.

- Mrs Drage advised that it wasn't easy to find volunteers for the event and consequently she was on her own for a while.
- Students from MBCC were not available.
- Less milk is required next time six 2L cartons would be sufficient.
- Light tower arrived earlier which was better.
- Event finished at 10.00pm.

Kate Ryan-Taylor, the Shire's Workplace Health and Safety Officer, attended the meeting to discuss workplace safety. New Work Health and Safety laws mean that a site induction is now required for volunteers. Also, insurance requirements were discussed. As the Shire is supporting, not running the event, volunteers representing groups such as St John Ambulance or bush fire brigades were required to provide copies of the organisation's public liability insurance.

It was also pointed out that volunteers must sign on when commencing a shift. Ms Ryan-Taylor offered to train a Committee Member to carry out site inductions.

Mr Hemmings advised he had recently attended a seminar run by WALGA about Roadside Vegetation Management. Environmental issues and sightlines on roads were some of the topics discussed.

6 AGENCY REPORTS

6.1 ROADWISE

See Attachment Two for the report from Ms Gardiner where the review and restructure of the WALGA RoadWise team was highlighted. Ms Gardiner spoke about the support service the RoadWise team would be offering to registered RoadWise Councils. Each respective Council would receive tailored support to help it work towards best practice road safety.

That it be recommended to the Council that the Shire of Plantagenet register as a RoadWise Council with WALGA.

6.2 MAIN ROADS WA

Mr Lenton reported on recent works underway and to be completed by Main Roads.

- Albany Highway Beattie Road intersection sealing and line marking to be completed.
- Woogenellup Road roundabout to be resealed.
- Beams still delivering these items to Albany.
- Wind farm rotors and parts transport still taking place.
- VMB trailer wheels were stolen at the recent Driver Reviver.

6.3 MOUNT BARKER POLICE

Snr Cons A Somerville reported that the number of visitors to the region was less than at the same time last year. No road fatalities have been reported on local roads.

He reported on hooning in town – this issue has become more common than speeding. Snr Cons Somervlle advised that on occasion police are driving from Perth down Albany Highway to Albany and then back again.

6.4 SHIRE OF PLANTAGENET

Mr Hemmings reported that winter grading was completed. Spraying of road verge drains were underway.

He reported on the intent to widen and seal Newman Road in Narrikup; the increasing use of tactile pavers around the Mount Barker townsite; the plan to continue widening Carbarup Road and the drainage maintenance works which were scheduled to take place later in the year.

6.5 MOUNT BARKER COMMUNITY COLLEGE

Mr Beck reported on the Leavers Alive event held recently at the MBCC. It was the 21st anniversary of the event and this year it focused on an accident between a car and an electric scooter. Mr Beck said he had received positive feedback. The suggestion was made to include year 10 students next year.

6.6 COMMUNITY MEMBER

Mrs Drage highlighted the lack of guide posts on the east side of Martin Street from Ormond to Oatlands Road.



A new Approach to Managing Road Safety

Program Overview

The RoadWise team has been evolving the RoadWise Program to improve the way we support Local Government manage road safety. The new approach, RoadWise Councils directly supports best practice road safety by strengthening the roles and functions within Local Government that have the greatest impact on road safety performance.

RoadWise Councils will offer a more focused and regular support service to Local Government. What this means is, the number of Local Governments that we can work with will be reduced so that we can allocate more time into supporting registered Local Governments, to be known as RoadWise Councils.

There will be no financial obligations for Local Governments to register, and the support you receive will be tailored for each Local Government and work towards best practice road safety goals. This could be anything from facilitating working groups, road safety rating, staff capacity building, policy development, etc (to be negotiated). The only requirements will be:

- a demonstrated commitment to road safety. This can be satisfied through a resolution of Council (or a declaration signed by the CEO) and
- at least two primary road safety contact/champion (at least 1 staff member)

WALGA is allocating only 10 Local Governments to each Road Safety Advisor, and we will allocate our time (~30-35 hours) supporting registered RoadWise Councils each quarter. This means some Local Governments will only receive minimal support under this new service arrangement.

What do Local Governments get?

Local Governments that register as a RoadWise Council, will be entitled to:

- Access to WALGA's road safety services (up to 1 week per quarter of Road Safety Advisor time to assist delivery) with a minimum of one meeting per quarter to discuss and record progress as a RoadWise Council
- Access to participate in WALGA's road safety training, professional development forums and other seminars/workshops/networking.
- Participate in 'RoadWise Recognised' program, a Local Government Road Safety Recognition and Incentive Program (more details at a later date).
- The use of the RoadWise logo



Road Safety Resources provided:

The primary resource is Road Safety Advisor time to assist Local Governments to prioritise, deliver and continually improve best practice road safety actions. The exact methods and tools will be determined through a consultative and collaborative process, as it is anticipated that each Local Government will have different priorities and adopt different approaches.

Examples of resources and tools that will help guide RoadWise Councils develop fit-for-purpose activity include:

- Road Safety Capacity Indicator Tool
- Road Safety Performance on Local Government Roads Reports
- Road Safety Target Setting Workshops
- Fleet and Workplace Road Safety Policy Templates and Resources
- Road Safety Rating Tool (updated version available for use mid-2023)
- Road Safety Governing Principles Workshops/Training (for elected members)
- Road Safety Practice Forums (for practitioners)
- Speed Management Guide for Local Governments (to be developed)

The Safe System Approach

The 'Safe System Approach to Road Safety', focuses on preventing fatal crashes and reducing the severity of injuries when collisions do occur. By recognizing that humans are fallible and will inevitably make mistakes, the Safe System approach promotes a holistic transport system with many built-in redundancies that are forgiving of driver error and greatly reduce the risk of serious injury or death.¹

The Safe System approach is considered best practice, it underpins both the State and National Road Safety Strategies. The following framework illustrates how the Safe System Approach applies with Local Government.
