GENERAL

7.1.1 ELECTION OF CHAIRPERSON

7.1.2 ELECTION OF DEPUTY CHAIRPERSON

It was agreed that election of a Deputy Chairperson was not required.

7.1.3 ADDRESS BY ROAD SAFETY OFFICER

Ms Andrea Smithson addressed the Committee by providing a report that introduced the RoadWise program and the 'Safe System' approach. Ms Smithson explained what RoadWise Committees can do and also provided some examples of activities that other Committees have been involved in. See report attached.

Ms Julie MacQueen commented that it is important that members of the Committee share jobs and do not leave everything up to the RoadWise Safety Officer.

Clarification was sought by Cr Clements in relation to Committee responsibilities.

The following items were raised:

- Placement of Speed Signs;
- Speed Signage Mount Barker Hill Road;
- Overhanging Trees Albany Highway (near Golf Club);
- Give Way Sign next to Railway;
- Pedestrian Crossings Albany Highway and Woogenellup Road;
- SAM Trailer:
- Inappropriate Signage in Road Works;
- Suggestion for 40km/h signs on back of Fire Trucks (Mr Wes Beck to bring a photo of the signs to the next meeting); and
- Footpath on Albany Highway Signs in the middle of the path.

Discussion was also held regarding the Road Traffic Device on Lowood Road. Mr Rob Stewart advised that this device does not meet the criteria to be classified as a pedestrian crossing. Mr Stewart noted that surveys had been carried out and information had been forwarded to Mr Matt Benson MLC who was going to raise the matter with Hon. Alannah MacTiernan MLA. Mr Stewart noted that Main Roads would prefer that the device was not made a crossing, however the Shire would prefer that it was.

Mr Rob Stewart to bring excerpts from the required Australian Standard to the next meeting.

Mr Rob Stewart noted that the Plantagenet News Editorial Committee is happy to receive a regular column from the RoadWise Steering Committee.

7.1.4 ADDRESS BY EACH MEMBER OF THE COMMITTEE AS TO THEIR EXPERIENCE AND WHAT THEY WOULD LIKE TO GET OUT OF THE COMMITTEE

Sgt Alan Spicer explained that he is the Officer in Charge at the Mount Barker Police Station and that he is new to RoadWise.

Ms Andrea Smithson advised that she is involved in seven (7) other RoadWise Committees and that she is very excited at the commencement of this Committee.

Mr Ian Bartlett explained that he has, in the past, been on a RoadWise Committee and hopes that he can provide some support and ideas for this Committee.

Mr Len Handasyde noted that he is here to learn.

Mr David Williss advised that he sits on the Committee as a community member. Mr Williss noted that he was previously a Shire Councillor and has therefore had a bit to do with roads. He noted that he is therefore keen to see safety increased on our roads.

Ms Julie MacQueen advised that she is the Customer Service Manager at Main Roads. Ms MacQueen noted that she has worked with RoadWise for four (4) years. Ms MacQueen noted that the RoadWise Committee is a great way to be involved proactively in road safety. Ms MacQueen advised that she is also involved in other Road Safety Programs around the state.

Cr John Mark advised that he sits on the Committee as a representative for the Shire Council.
