3 DISCLOSURE OF MEMBERS' INTERESTS

A Financial Interest was disclosed by Cr M Skinner Nature and Extent of Interest: Farming - 400 head of cattle

Authority to participate pursuant to Section 5.69 (3) (a) and (b) of the Local Government Act 1995

Approval has been received from the Department of Local Government via letter dated 9 January 2012, giving permission for Cr M Skinner and Cr J Moir to participate in matters relating to the Great Southern Regional Cattle Saleyards until 31 December 2012.

Mr J Fathers read aloud the letter, a copy of which is attached to these minutes.

4 MEETING WITH AGENTS

The Committee met with agent representatives and discussed each of the items within meeting agenda in turn.

The agents argued that fees should remain stable. Committee members advised that regular, modest increases in line with a self sustaining business plan would be likely. The Committee advised that it would reconsider this and in particular, the fees for private weighs (under 20 cattle).

The Chairman advised agents that a request had been received from Westcoast Livestock to trade at the saleyards. The view of the Saleyards Committee was that this should be beneficial to the Shire and that operationally it should work as there has been four agents in place before. The Shire considers that it had an obligation to allow free competition under the Trade Practices Act, 1974. Agents objected to the proposal on the basis of the investment they had made to the yards over the years, the dilution of their market share, operational difficulties and occupational health and safety concerns from overcrowding. It was requested that the Committee consider alternatives to allowing an additional agent into the Thursday sale. The Committee agreed to this, prior to making a final recommendation to the Council.

The Committee advised agents of the proposal for the existing Agent Agreements to be reviewed, with a view to all agents entering into new agreements by 1 July 2012. This was proposed to include an amendment to the fee structure to reflect the \$1.00 agent contribution being allocated towards capital maintenance, given the saleyards loans have now been paid off.

In regard to a name change, there was general agreement for 'Mount Barker Regional Saleyards'.

The Saleyards Manager provided an update in relation to the progress of the soft floor and new dirt yards.

In response to the question about business planning, suggestions for more drafting facilities, another ramp and a roof over the selling pens were raised. Agents suggested that there may be cost savings if a reduced wash down regime is employed in winter. The Committee advised that this was already being considered.

The Agents left the meeting at 2.22pm.

The Committee agreed that its previous decision to adopt the above fees should stand. The fees for private weighs (under 20 cattle), would be at the discretion of the Saleyards Manager, if for example the smaller lots were being weighed with bigger lots.

6 NEW AGENT – WESTCOAST LIVESTOCK

The Saleyards Committee has resolved that approval, in principle be granted to Westcoast Livestock to sell cattle at the Great Southern Regional Cattle Saleyards from 5 July 2012, subject to an Agent's Agreement being formalised and Westcoast Livestock agreeing to meet the Shire's minimum conditions.

The Committee noted the concerns raised by Agents and discussed a number of compromise options, noting that Westcoast Livestock would need to develop its own strategies to obtain a market share in this area. It was considered that legal advice be sought on the Shire's obligations under the Trade Practices Act, 1974.

Moved Cr L Handasyde, seconded Cr B Bell:

That it be a recommendation to the Council

That, notwithstanding the decision of the Committee held on 10 April 2012 and on the basis that legal advice confirms that the Shire can meet its obligations under the Trade Practices Act 1974, Westcoast Livestock be offered a 12 month agreement to trade at the saleyards on the last Tuesday of every month, subject to a minimum throughput of 150 cattle, an Agent's Agreement being formalised and Westcoast Livestock agreeing to meet the Shire's minimum conditions.

7 PROPOSED NAME CHANGE

The Saleyards Committee has recently been discussing a name change for the saleyards. The current name is considered too long and is not generally used. Suggestions are:

- Mount Barker Saleyards
- Mount Barker Regional Saleyards
- Mount Barker Cattle Saleyards
- Mount Barker Livestock Exchange
- Mount Barker Cattle Exchange

The views of agents were sought in this regard.

The Committee noted that there was general agreement for 'Mount Barker Regional Saleyards' amongst Agents and agreed that this was a suitable name.

Moved Cr L Handasyde, seconded Cr B Bell:

That it be a recommendation to the Council

That the 'Great Southern Regional Cattle Saleyards' be renamed the 'Mount Barker Regional Saleyards'.
