Mr John Fathers - Deputy Chief Executive Officer, read aloud the attached letter.

5 REPORTS OF COMMITTEE MEMBERS AND OFFICERS

5.1 MANAGERS REPORT - MARCH 2008

Sale Data

(1/3/08 - 31/3/08)

Total March numbers including MSA Sales were 7,447 head.
95 cattle have received replacement NLIS tags over this time.
Five animals has been put down or removed.
67 bales of hay have been fed out over this time.
There have been 95 cattle gone through for Private/Shipper Weigh Cattle.

General Business

(12/3/08 - 16/4/08)

We started irrigating the hay paddock again on 1 April and are continuing to do so as often as possible.

The small hand scanner (owned by myself) is being used more frequently. I would recommend that the Shire purchase one as it is a great asset to the NLIS scanning and reduces the risk of breaking the long wand while trying to scan in small/enclosed areas. As a preference, I would like to discuss the possibility of the Shire purchasing mine.

We have liaised with AD Contractors and Southern Haulage to remove the manure that Aquasol has cleaned out of the dams. AD Contractors are to remove the remaining manure and clean out the silt traps and any manure that is to be removed from the site will be weighed at Southern Haulage.

I have given notice of my intention to resign from the position of Saleyards Manager effective 9 May 2008, to take up a position managing live export cattle in Broome.

During discussion at the Great Southern Regional Cattle Saleyards Committee meeting held on 22 April 2008, Mr Lloyd confirmed that AD Contractors would be onsite this week to begin removing the sludge extracted by Aquasol. Mr Lloyd would contact Aquasol shortly with regard to the removal of some equipment left on site.

The Committee was agreeable to purchasing Mr Lloyd's hand scanner for a sum of \$2000.00. Mr Lloyd agreed to this.

Moved Cr S Grylls, seconded Cr K Forbes:

THAT the small hand scanner currently used at the Saleyards be purchased from Mr Warren Lloyd for a sum of \$2000.00.

Mr Lloyd raised the possibility of John Russell being engaged to seed and hay the paddock and the Committee was agreeable to this.

In regard to Mr Lloyd's impending departure, he advised that some spare sprockets, and bolts were being organised. The rifle licence would need to be transferred to another staff member. Mr Fathers advised that Steve Player had been organised to take on some of Mr Lloyd's duties in the interim period. For example, irrigation needs to be carried out about two days per week at the moment.

6 GENERAL BUSINESS

6.1 LETTER FROM COFFEY ENVIRONMENTAL ENGINEERS

Coffey Environmental Engineers arranged for the two silted up water monitoring bores to be re-drilled on Wednesday 2 April 2008. In response to the Council's request for advice on waste water re-use, the attached letter has been received.

During discussion at the Great Southern Regional Cattle Saleyards Committee meeting held on 22 April 2008, the Committee agreed that the proposal submitted by Coffey Environmental Engineers for a waste water re-use system be progressed as a matter of urgency and that the availability of the RIFP grant funds be investigated. Mr Lloyd advised that local analyst Charles Williams had recently collected and analysed water samples, however Coffey Environmental Engineers had not accepted these and collected their own samples for analysis. The Committee sought the reasons for this.

Moved Cr K Forbes, seconded Cr M Skinner:

That:

- 1. The waste water re-use scheme as described by Coffey Environmental Engineers be progressed and in this regard the Department of Local Government and Regional Development's approval be sought to fund this and a new irrigation pump as a matter of urgency.
- 2. Coffey Environmental Engineers be asked to advise why local analyst, Charles Williams should not carry out water sampling for the Saleyards.

6.2 2008/09 DRAFT BUDGET
