# 5 REPORTS OF COMMITTEE MEMBERS AND OFFICERS

#### 5.1 MANAGER'S REPORT – FEBRUARY 2010

# Sale Data

Total numbers including MSA since 22 January have been 13,833. Jan – 2,125 Feb – 7937 March inc 18 - 3771.

166 cattle have received replacement NLIS tags over this time.

11 animals have been put down or removed.

1363 bales of hay have been fed out over this time. From 22 Jan – 138, Feb – 428, to 18 March – 797.

There have been 2620 cattle processed for Private/Shipper Weigh. From 22 Jan – 237, Feb – 1384, to 18 March – 999.

# **General Business**

#### JANUARY

Mainly private weighs and feeding cattle going to the east.

#### FEBRUARY

Tim Beech commenced work on the 22<sup>nd</sup> February assisting with the wash down as Malcolm Spencer has left us.

Manure sales were up through February.

Double sales kept us busy especially when combined with a lot of private weighs and feeding cattle on hold to go to the east.

Two animals escaped off trucks. One has been retrieved and sent on, the other I know of its whereabouts and am keeping an eye on it.

Due to the large amount of feeding, 28 big square bales were purchased at \$40 per bale, plus transport.

On 14 February there were two people from a Victorian Saleyards looking at our yards and set up.

On 25 February the power went out during weighing, leaving animals still in stacking and weighing pens. A generator was hired out of Albany, but by the time we got it back and set up the power came back on.

# MARCH

Another two animals escaped off trucks. Both have been retrieved and sent on.

Single sales commenced on 4 March and the agents swapped sides on 11 March – All seems to have worked okay.

Dirt pens were cleaned out and we used Mount Barker Hire. This was all done within 5 hours.

On 15 March another 200 small square bales were purchase at \$4.50 per bale. We are in the process of carting this ourselves.

The Fax machine was replaced.

# 22 January to 18 March 2010

# **GENERAL COMMENTS**

The Eastern States buyers are still present and buying. This has increased the workload for looking after and managing these cattle until they are shipped east. Stewart is required to feed and monitor cattle seven days a week at the moment due to this.

Mount Barker Electrics have been helping us with the wash down pumps, we think it could have been a lightning strike that has caused a computer chip problem.

John Barden, the Livestock Compliance Officer from the Department of Agriculture and Food is still regularly attending the sales checking on compliance (ear notches, NLIS tagging and NVD's). No cattle have been sent home during this last period.

We are sending about 6 to 7 trucks a week to the Eastern States with cattle.

We are still using a lot of scheme water, due to the hot weather and large holdings.

We have been grazing around the ponds with sheep.

All parties involved with the sale yards seem to be happy, and no complaints.

#### Purpose

The purpose of this report is to present the annual environmental report for the Great Southern Regional Cattle Saleyards, as prepared by Coffey Environments.

#### Statutory Environment

The Annual Environmental Monitoring report has been prepared to satisfy Condition 8 of the Great Southern Regional Cattle Saleyards Licence Number 7407/7. The reporting requirements as specified in the licence are:

**'CONDITION 8 - ANNUAL REPORT** 

- 8 The licensee shall provide the Director, by 31 January each year, an annual environmental report containing data collected between the previous 1 January to 31 December. The report shall contain, but not necessarily be limited to:
  - (a) monitoring data or other collected data required by any condition of this licence;
  - (b) the total number of animals held on site on a monthly basis;
  - (c) a discussion of the operation of the project, compliance with conditions and environmental performance to date; and
- (d) an assessment of the data collected against any limits set in this licence.'

Coffey Environments have already forwarded the Report to the Department of Conservation and Environment.

#### **External Consultation**

There has been no consultation in relation to this report.

#### **Financial Implications**

#### **Strategic Implications**

There are no strategic implications for this report.

#### Officer Comment

The Executive Summary of the report states:

'Groundwater analytical results show relatively consistent physico-chemical properties of groundwater during the year. The minor fluctuations in groundwater quality can be attributed to seasonal rainfall infiltration. The variations in nutrient concentrations, however, range from a high in June and a low in December which is consistent with irrigation which ceased in June and may be correlated. Groundwater levels are calculated using field measurements of standing water in the bores and bore height survey data. Groundwater levels confirm that groundwater flows towards the south east of the site.

Surface water sample results from wastewater treatment ponds indicate varying concentrations of nutrients during 2009. Results from the SW1 location, representing irrigation water nutrient levels, have an average of 65mg/L total nitrogen, and 8mg/L total phosphorus.

The daily irrigation volumes are collated to provide monthly irrigation volumes for the site. This information, together with data for total nitrogen, total phosphorus, and biochemical oxygen demand is used to calculate the applied nutrient loading rate for the portion of the irrigation area that was utilised. The loading rates for the 6ha irrigation area have been calculated as 110.6kg/ha/yr of nitrogen, 10.7kg/ha/yr of phosphorus, and 0.201kg/ha/day BOD for 2009, which is within the site licence conditions.'

Based on the information in this report, Coffey Environments have recommended that the following points be considered for 2010:

- *Continue to undertake ammonia-N and NOx-N analysis for bores MB5, MB6, and MB7;*
- Review the extent to which groundwater down-gradient of the waste water treatment ponds is affected by increased nutrient levels, based on data available at the end of 2010.
- One of the two facultative ponds was de-sludged during 2008 however water quality in down-gradient bores remains elevated compared to other bores. Consideration should be given to the de-sludging of the second facultative pond. This might be undertaken during spring 2010.
- Undertake a mid-year review of the nutrient loading rates. If total phosphorus levels exceed 20mg/L in SW1, the site may exceed its annual loading limit, if irrigation rates are not managed.'

# OFFICER RECOMMENDATION

That the 2009 environmental report for the Great Southern Regional Cattle Saleyards, as prepared by Coffey Environments, be noted and endorsed.

During discussion, the view was expressed that further investigation should take place with the Department of Agriculture in relation to a hay crop, such as deep rooted perennials, which may remediate the nutrient levels identified by Coffey's report. COMMITTEE DECISION

# 6 GENERAL BUSINESS

# 6.1 WASTE WATER PROPOSAL – STIRLING COMPOST

An unsolicited submission has been received from Iain Allen from Stirling Compost in relation to various proposals for removal of sludge and treatment of water at the saleyards' settlement ponds. The claims made within the General Outline in this document are unsubstantiated and to some extent disagreed with.

Nevertheless, this information is provided for discussion as it is considered that some thought needs to be given to the reduction of manure entering the ponds and a long term solution for sludge removal (assuming the yards remain with the Shire of Plantagenet).

For information Ian Allen was involved with Aquasol, the company engaged to remove sludge from the ponds in 2007/2008. The method used by Aquasol involved mixing a flocculent into the pond water and then removal via a suction pump. This was not successful and a long reach excavator was eventually used to remove the sludge.

It is considered that, subject to the outcome from the Saleyards market sounding exercise, the Shire should seek input from an environmental engineer in this regard. It should be noted that the quotations are currently being sought for environmental services for the next 12 months for both the tips sites and saleyards.

During discussion, members agreed that this report be noted and that no further action be taken until the future of the ownership of the saleyards is more certain.

# 6.2 2010/11 FEES AND CHARGES

At its meeting held on 1 February 2010, the Committee agreed that it should review fees and charges at its next meeting, with further consideration to be given to an equitable fee for transit animals. The fees charged over the last five years are shown below. Fees charged in Midland are being sourced by the Saleyards Manager.

During discussion, the Chairman advised that he, the Shire President and Chief Executive Officer had recently had a meeting with Mr Redman in relation to this issue. Whilst the Shire's position was again put to the Minister, he was adamant that the current market sounding process would be followed through.
