5 REPORTS OF COMMITTEE MEMBERS AND OFFICERS

5.1 MANAGER'S REPORT - JUNE 2009

Sale Data

(1/6/09 - 30/6/09)

Total June numbers including MSA were 3992 head.

138 cattle have received replacement NILS tags over this time.

Three animals have been put down or removed.

76 bales of hay have been fed out.

306 cattle have gone through for Private/Shipper Weigh.

General Business

(18/6/09 - 22/7/09)

The chlorination shed was set up by Hydramet and put into operation on 10 July 2009. A pump still needs to be purchased to transfer water from the settling pond to the circulation tank.

We have cleaned out the dirt pens on the eastern side of the yards. Mount Barker Hire brought five in skip bins and the large Hiab Truck to do this job which lifted the bins into the pens. Steve Brown filled them with the bobcat and they were then lifted out. Each bin weighed an estimated 3.0 tonnes. A total of 48 bin lift were carried out which cleaned 16 pens. This took 13hours at a cost about \$1350.00 which is a huge saving on time from the way it has been done before and less mess. We still need to gravel the pens.

The boundary fence along the railway track and highway has been put up. We still have to do the wire. A small excavator with a post hole digger was hired as the bobcat would not drive the depot's digger attachment.

We have purchased 60 native plants to put car park area islands and around the office.

We are in the process of moving trough water isolation taps out of dirt pens and locating them on the outside area of the yards under the stairway. We used the excavator to dig the trenches.

We are still attempting to replace worn chains on lift gates at the weighbridge, as well as the welding links on stacking pen gates.

During discussion, the Saleyards Manager Mr Smith advised that the water re-use system had been set up with the exception of the pump from the sullage pond, which had been purchased. It was advised that the system was using quite a lot of chlorine. The Committee considered that there is only a need to switch the system on in periods of warm weather when pond water is required. The Saleyards Manager was also requested to review the optimum bacteria level for the system.

Purpose

The purpose of this report is to review the financial position of the Great Southern Regional Cattle Saleyards (GSRCS) for the period ending 30 June 2009.

A spreadsheet showing the current position of operating and capital budget items is attached for information. Since the March 2009 budget review has been undertaken, all items are now within reasonable range of the YTD budget, except for Grounds Maintenance, which has been subject to a large water account for \$12,303.00. Operating Income is also now ahead of budget and the overall operating surplus is significantly better than that budgeted.

6 GENERAL BUSINESS

6.1 ELECTRICAL PROBLEM - CANTEEN

The new lessee at the Saleyards Canteen, Wendy Swainson has recently complained to the Shire President about power problems in the canteen with appliances tripping the residual current devices (RCD).

For the Committee's information, there has been a problem with limitations to the power at the saleyards for some time. Appliances in the kitchen trip out quite often and whoever is in the kitchen has to re-set the trip switches. Wendy was advised of this problem and the way of fixing it before she started the lease.

A previous canteen operator advised that some days are worse than others and some days it didn't happen at all. There wasn't much of a problem when saleyards staff warmed up the kettle early so that everything wasn't switched on at once.

Western Power and Mount Barker Electrics have both been called to investigate the problem in the past and it seems that there is sometimes a lack of power reaching the facility, which could be caused by the fluctuations of other power users in the area.

Mount Barker Electrics have advised that it is possible to either ramp up the power to the particular circuit board or 'hot wire' the higher powered kitchen appliances into the circuit to stop them tripping. The building Surveyor, Mr Watkins is liaising with Mount Barker electrics to get the problem fixed if at all possible.

During discussion, the Saleyards Manager Mr Smith advised that Mount Barker Electrics were well aware of the problems and had been requested to make repairs as soon as possible. The Committee requested Mr Smith to investigate the water leak in the kitchen which it was considered may be contributing to this issue.

6.2 FEES FOR DESTRUCTION OF CATTLE AT OWNER'S REQUEST

Mr Smith also raised an issue of poor quality animals coming through the yards, whereby Mitchells had recently refused to transport the cattle from the yards. This had resulted in destruction of some animals and the view was expressed that there should be a higher charge for destruction of animals in these circumstances. The Deputy Chief Executive Officer and Saleyards Manager were requested to investigate the options and prepare a report for consideration on this matter.
