5 REPORTS OF COMMITTEE MEMBERS AND OFFICERS

5.1 MANAGER'S REPORT – SEPTEMBER / OCTOBER 2022

Prime Sales

Prime sales are expected to finish at end of November 2022 and we then will move into double/triple sales. We still have a shortfall in numbers compared to this time last year and will be interesting to see if numbers return.

Three Extra Dirt Pens

This project has now been completed and the yards are currently in use, with positive feedback received from operating agent.

Ablution Block Staff Canteen

The building is still incomplete with numerous tasks required before the building is ready to be put into service. An expected completion date has not been advised so far.

Saleyards Machinery Storage

The need for more secure storage at the saleyards has long been identified. With that in mind I would like to purchase a 20' sea container which can be positioned alongside the existing feed storage sea container. A roof can then be fitted between the two containers to provide an undercover park up bay for our tipper truck. We have sourced two quotes from local suppliers approx. \$4000 to \$5000 +GST range. It is considered that this can be accommodated within the operating expenditure budget.

Saleyards OSH Audit

Tribal Safety Solutions conducted an OSH audit of the facility on Tuesday 27 September, with minimal issues or non-compliance. They were minor obstructions to fire extinguisher/fire blanket access and some electrical cables on floor of weighbridges.

Sustainable Built Design

A consultant acting on behalf of the South Coast Alliance will conducting an energy audit of the saleyards on Tuesday 18 October 2022. (Thais facility and Sounness park will be audited).

This project builds upon the recent Roadmap to Zero work completed by the Alliance, which has enabled the identification of a variety of council owned built assets that have large ecological footprints based on their operational carbon footprint. This project will allow SCA member councils to accelerate the learning of know-how needed to fully capture the mitigation potential of retrofit actions in buildings.

Department of Primary Industries and Regional Development Weather Station

A request has been received from DPIRD to install a weather station at the saleyards. Personally I am reluctant to support the proposal on Shire property as it will increase the amount of people and or traffic coming and going and I also believe there will be a connection to heat stress modelling in Saleyards that may hinder our ability to conduct sale during the summer months.


The DCEO does not share quite the same view. DPIRD staff have had many staff visit the facility recently anyway. In discussion with the saleyards manager, it is apparent that there are many factors that can influence heat stress. The DCEO is of

the view this is a proactive move from the government department with oversight on animal welfare and therefore should be supported. Some perspectives from the Committee would be helpful.

PURPOSE

The purpose of this report is to review the financial position of the Mount Barker Regional Saleyards for the period ending 30 September 2022.

STATUTORY ENVIRONMENT

There are no statutory implications for this report.

FINANCIAL IMPLICATIONS

This report identifies the current operating position of the Saleyards.

STRATEGIC IMPLICATIONS

There are no strategic implications for this report.

OFFICER COMMENT

A spreadsheet showing the 30 September 2022 position of operating and capital budget items is attached for information.

Overall operating expenditure is \$195,653.00. This is \$83,158.00 below the YTD budget. Note that the 2nd tranche of insurance payments (approximately \$21,000.00) has not yet been made. Further, depreciation is currently \$25,184.00 below YTD budget, although this will change when updated valuation figures are imposed.

There has been expenditure totalling \$122,477.00 on capital budget items to date, being the outloading bugle ramp (\$18k), canteen / ablution block (\$83K) and new pens (\$21k).

Operating income is \$63,765.00, which is \$20,423 below YTD budget; saleyards fees are \$17,835.00 below YTD budget.

6 GENERAL BUSINESS

6.1 UWA INVESTIGATION – WASTE WATER TREATMENT

During discussion at the meeting held on 23 August 2022, the Deputy CEO advised that he would seek advice from the Shire's environmental analyst as to whether he is in a position to carry out any of this testing.

Mr Williams from West Coast Analytical Services has been provided with the materials and has advised that he is keen and able to do the work. His schedule has not permitted it at this stage, however, he will be able to carry it out by the end of the year. He does need to purchase some additional equipment such as the correct size beakers.

6.2 NATIONAL LIVESTOCK REPORTING SERVICE

During discussion at the meeting held on 23 August 2022 in regard to the National Livestock Reporting Service, members were generally of the opinion that market report has outlived its usefulness and had been taken over by electronic advice services provided by stock agents. Nevertheless, it was agreed to write to agents to seek their advice prior to a decision being made.

The comments received have been distributed to members separately.

During discussion, the view was expressed that the Shire should retain the service for now, but ask MLA whether a streamlined service could be available. Further, as this data is utilised for the compiling of the WA Young Cattle Indicator, the query was made as to whether the Boyanup saleyards also be represented. Therefore it was agreed that clarification be sought from MLA on the formulation of the 'WYCI'.
