4 PROGRESS REPORT AGAINST ACTION PLAN

4.1 The Presiding Member welcomed Megan Bob, Regional Community Manager, Silver Chain to the meeting and led discussions regarding the services provided by Silver Chain.

It was reported that, other than the Plantagenet Cranbrook MPS, Silver Chain was the only provider of CHSP services in the area.

Silver Chain also provides services to seniors being discharged from hospital or presenting at the emergency department and not admitted.

Silver Chain has committed to assisting seniors in the district to register with 'My Aged Care'. They will provide assistance on a regular basis once a month. Several options for locations to provide that service had been offered and it was felt that the foyer of the Mount Barker Cooperative on a Wednesday would be a good option. This was identified as a sustainable long term solution to the difficulties experienced by seniors trying to deal with 'My Aged Care'.
