#### 5.1 PROGRESS TO DATE TO SECURE WATER SUPPLIES

Mr Lynch presented a report to the Committee discussing options to secure water supplies for use in the townsite of Mount Barker. See Attachment One.

The Committee agreed that the preliminary costings are very favourable. Mr Lynch said discussions are taking place with the Water Corporation regarding water grant applications.

Mr Lynch suggested that it would be best to complete the program in stages. The Committee agreed that maximum catchment from all possible sources was imperative. Mr Lynch suggested a sump at the base of the Cricket Oval with a float switch or tap system to transfer water.

Mr Lynch asked that the report be reviewed annually prior to the start of the budgetary process. Councillor Pavlovich suggested a workshop be held prior to the February Council Meeting to discuss options.
