



Mount Barker Regional Saleyards Summary of Advisory Committee Matters Filling out NVDs

Saleyards staff have recently noted that NVD forms are often not completed correctly. Vendors need to use the correct form (C0413), which must be fully completed.

In particular, for sale cattle, the Consigned To section should read the Agent's Name and Address.

Destination (if different) of cattle should read 'Mount Barker Regional Saleyards'. The address is 32416 Albany Highway, Mount Barker and include PIC number WJSY0002.

The Declaration section must have the full name of the vendor, as well as their address and phone number. It must also be signed. For reference, the Department of Agriculture has published the common PICs shown here.

2018/2019 Budget and Fees

The 2018/2019 budget for the Shire of Plantagenet has been adopted. The fee for Cattle Weighing & Penning has been set at \$9.20 (+GST) per head, an increase of 1.7%.

Capital works include modifications to aeration ponds (\$5,000), painting/protection of roof and walkways (\$23,000), servicing of the irrigation pump diesel motor (\$5,000) and servicing of Alies scanner (\$5,000)

In addition, an allocation of \$45,000 has been made towards a 7th receival ramp. The Council will shortly call for tenders for construction of the ramp. Depending on the prices that come back, a final decision will be made as to whether to go ahead this year.

Saleyards Manager's Report

Cr Marie O'Dea and Assistant Saleyards Manager Erika Henderson attended the 2018 Australian Livestock Markets Association (ALMA) Expo in Casino NSW from 24 to 26 July 2018. Previous attendees have benefitted and the knowledge gained from exposure to industry trends has resulted in improvements at Saleyards.

Cr O'Dea has also secured a position on the ALMA Board which will be beneficial in order to have the 'inside running' on national issues. Having a representative at that level has been useful as it has provided intelligence from a variety of stakeholders.

Representatives from the Shires of Plantagenet and Katanning have presented ALMA with a joint bid for a future ALMA conference to be held in the Great Southern.

While the ultimate decision will be with ALMA, a suggested conference program has the majority of activity in Katanning, with the attendees working their way down to Mount Barker and then Albany for the main conference dinner.

We believe this will give conference attendees and their partners opportunities that may not normally accrue for an Eastern States conference. This would also enable the attractions of Katanning, Mount Barker and Albany to be showcased and put help to put WA saleyards on the map for attendees. Finally, after ten years as Manager of the yards, it will shortly be time to hand over the reins to someone else. I will be taking some extended leave but I will still be around to help out for a while when required.

The Shire will advertise for a replacement manager in the near future and we plan to have a good handover period.
